Eenparig Besluit / Unanimously Resolved

1. Seeing that seven (7) of the fourteen (14) houses are already registered in the tenants names, a survey be

conducted first to determine qualifiers and non-qualifiers in terms of the National Housing Policy and Council's Allocation Policy, and then Council can take a decision on the way forward with the remaining seven unregistered houses.

2. That if Council wishes to proceed with the demolition and rebuilding of these houses, authorisation be sought from the MEC Human Settlements to fund the demolishing and rebuilding of the 14 houses.
3. That Town Planning determines as a matter of urgency the possibility to demolish the seven Strydom Street houses (No's 3, 5, 7, 9, 11, 13 & 21) and rebuilt new houses.
4. That these houses also be referred to the Heritage Authority to determine as a matter of urgency whether there is any historical value to them.
