THE Langeberg's newly elected ward committee members were officially inaugurated on Thursday, 8 December at the Callie De Wet Hall in Robertson. Ward committee members are elected to represent the community in a ward and report on matters affecting the ward or emanating from the ward to the municipality, through its ward councillor.

What are the functions of ward committee members?

A ward committee should effectively support the elected ward councillor for that ward and serve the community by:

- Attending meetings of the ward committee.
- Submission and tabling of reports and plans addressing the needs and priorities of the ward and to provide feedback on the functions rendered by the municipality that impacts on the ward, in order to formulate recommendations to be submitted to the municipality through the ward councillor.
- Facilitating feedback on matters raised with the Council through the ward councillor.
- Doing door-to-door campaigns and arranging interaction with substructures in the ward, such as street committees.
- Keeping record of and attending to all complaints, queries and requests received from the community in the ward and to attend to it, through the ward councillor.
- Distributing publications as required.
- Managing and updating ward profiles as well as the database of the indigent households.
- Participation in plans and programmes of municipalities and other spheres of government impacting on the ward development.
- Facilitating participation by the community in all affairs of the municipality.
- Fostering a good working relationship with CDWs operating in the ward.

What are the principles of good governance to be complied with by ward committee members?

Community interest

Members should strive to serve the best interest of the community from which they are elected, by recom-

mending municipal programmes that are community centred, driven and implemented, recognising any diversity in the ward.

Integrity

Members should always act with integrity in the execution of their functions as members of the ward committee, without fear, favour or prejudice. Members may not use their positions as ward committee members for private gain or to improperly benefit any third party.

Objectivity

Members should make decisions on merit, based on the mandate received from their ward. They may not act in any manner that will compromise the credibility, impartiality or independence of the ward committee.

Accountability

Members are accountable to the ward community that they serve.

Regular report back

The ward councillor and members of the ward committee are responsible for feedback to the community and the constituency of their ward.

Transparency

Members promote transparency and should be open and honest about their actions and those of the ward councillor and should welcome community enquiries, thereby creating trust and respect between all role-players.

Consensus

Ward committees should work on the basis of consensus reached in the committee, failing which, a majority decision will prevail.

Leadership

Members should provide leadership to the ward and set a good example of responsible citizenship.

Public Participation

The ward committee members must in all their actions deepen and strengthen public participation and local democracy.

Wykskomiteelede word verkie字 om die gemeenskap binne 'n wyk te verteenwoordig en om oor verskeie aangeleenthede wat die wyk raak, verslag te doen en te verskeer dat die munisipaliteit inligting ontvang via die wyksraadslid.

Wat is die funksies van die wykskomiteelede?

Die funksie van 'n wykskomitee is om die verkose wyksraadslid vir die betrokke wyk by te staan en om die gemeenskap te dien deur:

- Vergaderings van die wykskomitees by te woon.
- Verslae in te dien en voorstelle te maak om die behoeftes en prioriteite van die wyk te identifiseer en aan te spreek, en om terugvoer te gee oor munisipale dienslewing wat inwoners raak sodat aanbevelings hieroor via die wyksraadslid aan die munisipaliteit deurgegee kan word.
- Terugvoer te fasilitateer oor aangeleenthede na die Raad deurgegee.
- Deelname aan deur-tot-deur aksies en die reel van interaksie met strukture in die wyk soos byvoorbeeld straatkomitees.
- Rekord te hou van en aandag te gee aan klages, navrae en versoek van die gemeenskap in die wyk en om dit deur te gee aan die wyksraadslid.
- Inligting deur te gee aan die gemeenskap indien so versoek.
- Die bestuur en opdatering van wyksprofiel sowel as die databasis van deernishuishoudings.
- Deelname aan planne en programme van die munisipaliteit en ander sfere van regering wat 'n invloed kan uitoeft op ontwikkeling binne die wyk.
- Die fasilitateer van gemeenskapsdeelname in alle munisipale aangeleenthede.
- 'n Goeie werksverhouding met die gemeenskapskakelwerkers wat binne die wyk werkzaam is, op te bou.

Wat is die algemene beginsels van goeie regering waaraan wykskomiteelede moet voldoen?

Belang van die gemeenskap

Wykskomiteelede moet streef om in die beste belang van die gemeenskap wat hulle verkie字 het, op te tree

deur munisipale programme voor te stel wat gemeenskapsgesentreerd is en gedryf en implementeer word met inagneming van diversiteit in die wyk.

Integriteit

Wykskomiteelede moet altyd met integriteit optree in die uitvoering van hul funksies as wykskomiteelede, sonder vrees, vooroordeel en begunstiging. Lede van komitees mag nie hul posisies as wykskomiteelede vir privaat wins misbruik nie, ook nie vir oneerlike voordeel vir'n derde party nie.

Objektiwiteit

Komiteelede moet besluite op meriete neem, gebaseer op die mandaat ontvang vanaf hul wyk. Hulle mag nie op enige wyse optree wat die geloofwaardigheid, onpartydigheid of onafhanklikheid van die wykskomitee in die gedrang sal bring nie.

Rekenpligtigheid

Komiteelede is rekenpligtig aan die wyksgemeenskap wat hulle dien.

Terugvoering

Komitee- en wykslede is verantwoordelik vir gereeld terugvoering aan die gemeenskap van hulle wyke.

Deursigtigheid

Komiteelede moet deursigtigheid bevorder en moet oop en eerlik wees insake hul aksies en dié van die wyksraadslid en moet navrae vanaf die gemeenskap verwelkom en sodoende vertroue en respek tussen alle rolspelers bevorder.

Konsensus

Wykskomitees moet streef na konsensusbesluite. Indien onmoontlik, sal'n meerderheidsbesluit geld.

Leierskap

Wykskomiteelede moet leierskap toon en 'n goeie voorbeeld wees van 'n verantwoordelike landsburger.

Openbare deelname

Die wykskomiteelede moet in hul kapasiteit as wykskomiteelede deur al hulle handelinge openbare deelname en plaaslike demokrasie versterk en aanmoedig.




Farewell / Tot siens

Bringing hope to Zolani

IN the poorest part of Zolani outside Ashton, Pastor Fanie Tshoto started a church in a derelict building, the Apostolic Faith Mission Church.

His intention was to give people a positive outlook on their lives.

In a dream Fanie saw how wonderful it would be to have a place where adults could learn a trade, enabling them to look after themselves.

When he came into contact with Gerard Velthuizen (Chairman of the Conkim Foundation and director of a housing corporation, Woonwize in Vught, the Netherlands) the dream became reality. Gerard gave Fanie his word that he would build him a Skills Centre.

Pastor Fanie Tshoto had a dream of having a community centre in the Zolani township, to provide a safe place for unemployed people to learn various skills in order to make a better life for themselves. The centre was originally run in a small building, which is now condemned, and together with the AFM Church and Conkim, the new purposed building was realised.

Building started on January 16, 2009 and the official opening took place on December 5 the same year. This gave local

people the opportunity to create their own job environment and hence improve their future.

The Zolani Hope Centre (ZHC) provides skills and upliftment programmes to those who want to learn the skill of carpentry and gardening. Many people who have come through the centre are now working in jobs as carpenters, or have learnt the skill to cultivate vegetables in their own back gardens.

The centre also provides aftercare for 40 young children, where they come for extra tuition after school. There is a large kitchen run by Gene Makhitha and she provides the most delicious snoek and other fresh fast food on a daily basis. Gene also provides the children in aftercare with a cup of hot soup and bread twice a week.

Other services and skills is a youth centre, run by youth leaders Thembela Magangqa and Anele Mnqovo. The young people are taught choir singing and to play musical instruments. Pastor Tshoto is the chairman of the trust and also has a congregation of 60 devotees in his church at the ZHC.

The centre provides permanent employment to nine residents of Zolani. The four men in the wood workshop provide the community with beautiful

furniture made from pine and also manufacture top quality furniture made from old wine barrels.

Tshozi Sicelo runs the large garden and provides fresh vegetables to the community and also to the popular food stores in Montagu.

There are many success stories at the ZHC. People at the centre are all

products of a dream that became a reality when Conkim saw the need to uplift the lives of people who needed a job or a skill.

The centre is a place of worship, a green house for adults who need to better their lives, a safe haven for young children and a place of growth for the youth. No one is turned away.

The centre is open from 08:00 to 18:00 from Monday to Saturday.
