Langeberg tables new budget

The Langeberg Municipality's budget for the new financial year is presented against the backdrop of a global economic crisis. Most European countries are facing serious economic crises and record-high unemployment rates.

South Africa is no different to the rest of the world. "We are faced with high fuel prices, the weakening of the local currency, a deficit in the current account of the country, and an increase in food prices and electricity – all inflationary pressures that are prevalent in our economy," the Langeberg Municipal Mayor Diana Gagiano said.

While the International Monetary Fund (IMF) expects global economic growth for 2013, the projected growth for South Africa is very low. In 2012, South Africa's Gross Domestic Product (GDP) growth was only 2,3%.

The forecast for 2013 is 2,8% and 4,1% for 2014. "This means that we are still not out of the financial crisis and we should ensure that we spend our moneys wisely," Gagiano said.

With regards to inflation, official data showed South Africa's consumer inflation jumped to 5,9% in February from 5,3% in January.

The main drivers of inflation are higher transport costs, an increase in the price of electricity and basic foodstuff like meat, milk and eggs. Statistics South Africa reported that inflation ticked half a basis-point higher, to come within striking distance of the Reserve Bank's 6% ceiling.

Reserve Bank governor Gill Marcus admitted that inflation may average around 6,3% in the third quarter of this year. These statistics indicate tough economic times ahead.

"We are mindful of the fact that the majority of our citizens in the Langeberg municipal area are trapped in the poverty gap.

"To provide for the poorest of the poor, the municipality has made provision in the form of indigent subsidies for free basic services, including refuse, water, sewerage and electricity, to the value of over R25 million.

"A relatively small tax base is a threat to the municipality's financial viability. We will have to make tough decisions and begin to apply austerity measures to reduce costs and create an effective and efficient administration," Gagiano said.

The municipality would like to keep all increases on par with the inflation rate but the reality is that some increases are out of our control and failure to budget appropriately for these costs can have a negative impact on the municipality's ability to deliver services to the citizens of the Langeberg municipal area.

In order for us to deal with poverty, unemployment and inequality in our society, the municipality is busy with a process to establish an Economic Development Partnership which will bring together the



private sector, government and community-based organisations around one table to discuss the road to economic development. There are endless opportunities within our municipal area.

Salient features of the 2013/2014 budget

The Medium Term Revenue Expenditure Framework (MTREF) for the next three years has been prepared in terms of the Municipal Finance Management Act (MFMA) and the Municipal Budgeting and Reporting Regulations as prescribed by National Treasury, and also taking into account the guidelines of MFMA Budget Circular 66 and 67.

The Municipality's 2013/14 budget amounts to R509 602 780, represented by a capital budget of R53 589 730 and an operating budget of R456 013 050.

The capital budget over the three-year period is represented as follows:

Own municipal funds (reserves)

The accumulated surplus will be used to finance the depreciation on assets as the impact of the full provision for depreciation will make the tariffs not affordable to residents. The financing of the depreciation will be phased in over a medium to long-term period.

Sustainability of municipality

The way that the budget is funded will ensure that the municipality will be sustainable on the short term.

The full effect of huge increases in electricity tariffs, which the municipality has no control over, may in the long run impact nega-

tively on the sustainability of the municipality.

This is a huge concern for the municipality.

Impact on rates and tariffs

The way that the budget is funded will ensure that tariff increases will range from 5,9% to 8%.

The municipality has no control over the increases of electricity tariffs and with the 8% increase in electricity tariffs of Eskom, the increases in tariffs will have a negative impact on the local economy.

The operating budget for 2013/14 will be financed as follows:

- Charged for electricity, water, refuse and sewage – R316 034 220

Expressed as a percentage, property rates represent only 7% of the municipality's total revenue whilst the revenue out of electricity represents 57% of the total revenue.

Langeberg lê nuwe begroting ter tafel

Die Langeberg Munisipaliteit se begroting vir die nuwe finansiële jaar word voorgehou teen die agtergrond van 'n wêreldwye ekonomiese krisis.

Die meeste Europese lande word deur ernstige ekonomiese krisisse in die gesig gestaan en rekord-hoë werkloosheidsfyfers.

Suid-Afrika is geensins anders nie. "Ons kom voor hoë brandstofpryse te staan, die verswakking van die plaaslike geldeenheid, 'n tekort in die lopende rekening van die land, en 'n styging in kospryse en elektrisiteit – alles inflasionele druk wat aan die orde van die dag is in ons ekonomie," het die Langeberg Munisipaliteit se burgemeester, Diana Gagiano, gesê.

Terwyl die Internasionale Monetêre Fonds (IMF) globale ekonomiese groei vir 2013 verwag, is die vooruitgeskatte groei vir Suid-Afrika baie laag. In 2012 was Suid-Afrika se groei op die Bruto Binnelandse Produk (BBP) slegs 2,3%.

Die voorspelling vir 2013 is 2,8% en 4,1% vir 2014. "Dit beteken dat ons steeds nie uit die finansiële krisis is nie en ons moet verseker dat ons ons geld wys spandeer," het Gagiano gesê.

Wat inflasie betref, het amptelike data getoon dat Suid-Afrika se verbruikersinflasie tot 5,9% opgeskiet het in Februarie van 5,3% in Januarie. Die hoofdrywers van inflasie is hoër vervoerkoste, 'n styging in die prys van elektrisiteit en basiese kosprodukte soos vleis, melk en eiers.

Statistieke Suid-Afrika het verslag gedoen dat inflasie op 'n halwe basispunt hoër te staan gekom het, binne trefafstand van die Reserwebank se plafon van 6%.

Die Reserwebank-president Gill Marcus het toegegee dat inflasie op 'n gemiddeld van rondom 6,3% te staan kan kom in die derde kwartaal van die jaar. Hierdie statistiek dui op taai ekonomiese tye wat voorlê.

"Ons is bewus van die feit dat die meerderheid van ons burgers in die Langeberg munisipale area vasgevang is in 'n armoede-groef. Om vir die armste van die armes te voorsien, het die munisipaliteit voorsiening gemaak vir armoedesubsidies vir gratis basiese dienste, insluitend vullis, water, riolering en elektrisiteit, ter waarde van meer as R25 miljoen."

"n Relatief klein belastingbasis is 'n bedreiging vir die munisipaliteit se finansiële volhoubaarheid. Ons sal moeilike besluite moet neem en begin om spaarsamigheidsmaatreëls in te stel om koste te bestaar en 'n effektiewe en doeltreffende administrasie te skep," het Gagiano gesê.

Die munisipaliteit sal alle stygings in lyn met inflasie wil hou, maar die realiteit is dat sommige stygings nie binne ons beheer is nie en die versuum om toepaslik vir hierdie kostes te begroot, kan 'n negatiewe impak hê op die munisipaliteit se vermoë om dienste te lewer aan die inwoners van die Langeberg munisipale area.

Vir ons om met armoede, werkloosheid en ongelykheid in ons samelewings te werk, is die munisipaliteit in 'n proses om 'n Ekonomiese Ontwikkelingsvennootskap op die been te bring wat die pri-

vaatsektor, regering en gemeenskapsgebaseerde organisasies om een tafel sal saambring om die pad na ekonomiese ontwikkeling te bespreek.

Daar is tallose geleenthede in ons munisipale area.

Usodolophu wase Langeberg, uDiana Gagiano xeshikweni esithi tha-ca kwibhunga uhlahlo-lwabiwo mali uthe, "Umasipala wase Langeberg uqulunqa oluhlahlo-lwabiwo mali ngexesha ihlabathi lonke litsala nzi-ma kwezoqoqosho. Amazwe amaninzi aseYuropu ajamelene nentle-kele enzima ngokwezoqoqosho kwakunye namaqondo aphezulu entswela-ngqesho. Umzantsi Afrika awahlukanga kwaphela kuleme-ko amanye amazwe ohlabu akuyo. Sijongene nokunyuka kwamaxabi-so epetroli, ukudobala kweRanti, ukuhla korwebo lwezinto ezithu-nyelwa ngaphesheya nokunyuka korwebo lezinto ezithengwa kumaz-we angaphesheya, ukunyuka kwamaxabiso okuya kwanombane, konke oku kubeka uxinezeleko kwizinga lokunyuka kwamaxabiso eMzantsi Afrika.

Uitgawe kategorie-stygings vir 2013/2014

Salarisse en lone (insluitend verhogings): 7,95%

Loononderhandelings is tussen die unies en die Suid-Afrikaanse Vereniging vir Plaaslike Regering gefinaliseer en 'n salarisverhoging van 6,95% sal van 1 Julie af geïmplementeer word. 'n Begrote 7,95% maak egter voorsiening vir verhogings soos kerf-verhogings, verhogings in mediese fonds-bydraes, aftree-annuïteite, die implementering van werksevaluering, en die vul van vakante poste, afhangend van die vereistes. Die minister van finansies sal die verhogings van raadslede in die 2013/14-boekjaar goedkeur, en die verhoging sal ook van 1 Julie af geïmplementeer word.

Algemene uitgawes: 7,50%

Daar word aangeneem dat kostes vir dienste en brandstof sal toeneem bo die huidige inflasieteiken van 5,9%. Daar word ook aangeneem dat die kapitale projekte vir 2013/14 voltooi sal word aangesien daar vir waardevermindering begroot is volgens Algemeen Aanvaarde Rekenkundige Praktyk (GRAP). Waardevermindering op nuwe kapitaal-uitgawes word bereken teen verskillende tempo's, wat wissel van nege tot 20 jaar, afhangend van die bate.

Herstelwerk en onderhoud (verhoging): 7,00%

Daar word aangeneem dat munisipale infrastruktur en bates onderhou sal word soos in vorige jare en dat geen groot breke in die finansiële jaar sal voorkom nie.

Kapitale kostes (afname): 16,96%

Daar word aangeneem dat rentekoerse stabiel sal bly in die finansiële jaar, maar die voorsiening vir kapitaal is nie verminder nie.

Grootmaat-aankope (water en elektrisiteit): 8,00%

Daar word aangeneem dat elektrisiteitstariewe van Eskom met 8% sal styg van 1 Julie af, soos goedgekeur deur die Nasionale Energiegoureguleerder van Suid-Afrika (Nersa).

Die voorgestelde tariefverhoding vir 2013/2014 is soos volg:

Die MTREF-multijarig-begroting sal effek gee aan die strategiese oogmerke van die Langeberg Munisipaliteit.



The expenditure category increases for 2013/2014

Salaries and wages (including increments): 7,95%

Wage negotiations were finalised between the unions and the South African Local Government Association and a salary increase of 6,95% will be implemented from 1 July. However, the budgeted 7,95% has made provision for increments including notch increases, increases in medical aid, retirement annuity, implementation of job evaluations, and the filling of vacant positions, depending on the requirement. The minister of finance will approve increases of councillors during the 2013/14 financial year, and the increase will also be implemented as from 1 July.

General expenses: 7,50%

It is assumed that costs for services and fuel will increase above the current inflation target of 5,9%. It is also assumed that the capital projects for 2013/14 will be completed during the financial year as

there was budgeted for the depreciation of such projects as per General Recognized Accounting Practice (GRAP). Depreciation on new capital expenditure is calculated at a varying rate ranging between nine and 20 years depending on the nature of the asset.

Repairs and maintenance (increase): 7,00%

It is assumed that municipal infrastructure and assets will be maintained as per previous years and that no major breakages will take place during the financial year.

Capital costs (decrease): 16,96%

It is assumed that interest rates will be stable during the financial year, but the provision for capital has not been decreased.

Bulk purchases (water and electricity): 8,00%

It is assumed that electricity tariffs of Eskom will increase by 8% as from 1 July, as approved by the National Energy Regulator of

South Africa (Nersa).

The proposed tariff increases for 2013/2014 are as follows:

- Residential and business property rates will increase by 7,5%.
- The increase of water tariffs will be 7,5%.
- The increase of sanitation tariffs will be 7,8%.
- The tariff increase for refuse removal will be 8,5%
- The increase of electricity tariffs will be 7%.

The Langeberg Municipality's consultation process on its draft Integrated Development Plan (IDP) review and budget will be held during April, where various community organisations and representatives will have the opportunity to give their input. Council will consider these inputs before the approval of the budget in May.

The MTREF multi-year budget will give effect to the strategic objectives of the Langeberg Municipality.

Wards hard at work

All twelve wards within the Langeberg municipal area are hard at work to complete their individual poverty alleviation projects.

Council members of all twelve wards received an allocation of R100 000 to be used towards a specific project within their respective wards. The projects, as approved by Council, were subjected to certain conditions.

These conditions included that all projects should be poverty alleviation projects, it should be implemented during off-season, and should commence during the 2012/2013 financial year.

Council also indicated that beneficiaries of these projects should be remunerated according to EPWP rates, all projects should be in line with the specific wards' IDP as well as the Neighbourhood Development Grant.

The projects, as identified by each council member, are as follows:

Ward 1 – Councillor J Burger

Project: Rejuvenation of the entrance of Môreson. Greening, paving and water supply to sustain the plants at the entrance of Môreson.

Jobs created: 10 persons plus 2 semi-skilled persons.

Ward 2 – Councillor S Mafilika

Project: Upgrading of open public space in Burwana Street.

Preventative work will be done to avoid erosion, introduce vegetation as well as paving.

Water supply to maintain the plants will be provided in this area. The workforce will come from the unemployed in this ward.

Jobs created: 10 unskilled persons plus 2 semi-skilled persons.

Ward 3 – Councillor E Turner

Project: Development of new park in Extension 15. This is the building of a new park, the site will be cleared and new vegetation will be introduced.

Paving of a 120m x 1m walkway so as not to inhibit pedestrian movement. Department parks and amenities and civil engineering will assist.

Jobs created: 10 unskilled and 3 semi-skilled persons.

Ward 4 – Councillor R Kortje

Project: Upgrading of entrance to Happy Valley. This area will be re-vegetated, the corrugated iron walls of the stadium will be repaired and a 150m x 1m walkway will be paved out to prevent further erosion.

The area will also be fenced off for protection as this is a high human traffic area.

This project will be done in collaboration with

the department of Parks and Amenities and Civil Engineering.

Jobs created: 10 unskilled plus 2 semi-skilled persons.

Ward 5 – Councillor DA Hull

Project: Upgrade recreational park at the entrance to McGregor.

The park will be fenced in, park benches and shelter will be erected and park will be re-vegetated.

Unemployed persons will be utilised under the supervision of experienced personnel.

Jobs created: 10 unskilled plus 2 semi-skilled persons.

Ward 6 – Councillor D Janse

Project: Upgrading of pavement in Muller Street Robertson. This project was approved in the EPWP business.

Erect shelter (rural area) this project will be done in the next financial year.

Jobs created: 10 unskilled and 2 semi-skilled persons.

Ward 7 – Councillor J Kriel

Project: Upgrade of David Street.

This project was referred to the Director Civil Engineering by the ward Councillor.

Ward 8 – Councillor S van Eeden

Project Completed: Building of drop-off zone at school.

Ward 9 – Councillor T de Koker

Project: R20 000 was donated towards Silver Threads project and the rest will be used to rejuvenate the entrance in Ashton.

Ward 10 – Councillor E Zwedala

Project: Upgrading of main activity route in Zolani. This project will be linked to the current EPWP project underway in Zolani through the Engineering Department.

Jobs created: 10 persons.

Ward 11 – Councillor JDF van Zyl

Project: Erection of bus shelters, road works and paving.

The Department of Roads at the Cape Winelands District Municipality has assisted in choosing the site as per regulations, these shelters must be erected according to the specifications of the Roads Department in the Province. Drawings of the structure have been provided.

Jobs created: 2 semi-skilled (small contractor) 7 unskilled.

Ward 12 – Councillor EMJ Scheffers

She says she's been on the waiting list for 26 years and she only regrets that her husband, who passed away, is not able to experience it with her.

"I am very thankful. It's only through the grace of God that I am to move into my new home."
