A glance at this year's budget

Municipality ready for action

The 2014/15 budget has been tabled at the council meeting on 28 March. Since then an extensive public participation and consultation process was followed during April and May 2014.

The budget, policies and Integrated Development Plan for the 2014/15 to 2016/17 financial year were overall well received and approved by Council on 27 May in terms of section 16(1) of the Municipal Finance Management Act, No. 56 of 2003.

The budget, fees, costs and tariffs will be implemented with effect 1 July 2014.

The said council resolution and all other relevant documents may be inspected at all Langeberg municipal offices and public libraries during normal office hours and are also available on the municipal website at www.langeberg.gov.za. The main features of the budget are listed below.

1. Increases for rates

The average increase of rates for the various property categories are as follows:

- Residential: 8,7%
- Business property: 7,35%
- Bona fide farmers: 10%

■ Public benefit organisations: 10%.

2. Tariff increases

The average increases for tariffs are as follows:






- Water tariffs: 7,5%
- Sanitation tariffs: 6,9%
- Refuse removal: 7,9%
- Electricity tariffs: 7,39%

3. Sundry tariffs

The tariffs for community halls, swimming pools, sport fields and cemeteries continue to be a serious problem for the municipality. These tariffs have been adjusted but they are not cost reflective as required by the Municipal Finance Management Circular No. 70.

The under recovery is so huge to the extent that it is not affordable for the consumers to effect a single increase. However, the municipal council have resolved to develop a pricing strategy to phase in the necessary increases over a period of time in a manner that spreads the impact on consumers.

The municipality's 2014/15 budget amounts to R547 212 260, represented by a capital budget of R54 440 170 and an operating budget of R492 772 090.

3. Ezinye Iintlawulo

Nuwe begroting

Die Langeberg Munisipaliteit se 2014/15-begroting is op 28 Maart voor die raad ter tafel gelê. Sedertdien is 'n uitgebreide publieke deelname- en konsultasieproses gedurende April en Mei gevolg.

Die begroting, beleide en geïntegreerde ontwikkelingsplan vir die 2014/15 tot 2016/17 finansiële jaar is oor die algemeen positief begroet en is op 27 Mei in terme van artikel 16(1) van die Wet op Munisipale Finansiële Bestuur Nr. 56 van 2003 goedgekeur.

Die begroting, heffings, kostes en tariewe sal met onmiddellike effek op 1 Julie vanjaar geïmplementeer word. Dië raadsbeslissing en alle ander relevante dokumente kan gedurende kantoorure by alle munisipale kantore en biblioteke in die Langeberg besigtig word en is ook beskikbaar op die munisipaliteit se webtuiste by www.langeberg.gov.za. Die hoofkenmerke van die begroting sluit in:

1. Stygings in heffings
Die gemiddelde verhoging in heffings vir die onderskeie eiendoms-kategorieë is as volg:
 - Residensieel: 8,7%
 - Sake-eiendom: 7,35%
 - Bona fide boere: 10%
 - Openbare welsynsorg-

ganisasies: 10%.

2. Tariefverhogings

Die gemiddelde verhogings in tariewe is as volg:

- Watertariewe: 7,5%.
- Sanitasietariewe: 6,9%.
- Vullisverwyderingstariewe: 7,9%.
- Elektriesiteitstariewe: 7,39%.

3. Diverse tariewe

Die tariewe vir gemeenskapsale, swembaddens, sportterreine en begraaftplase bly steeds 'n groot probleem vir die munisipaliteit. Hierdie tariewe is aangepas, maar is nie so koste-reflektierend soos vereis deur die Munisipale Finansiële Bestuur-omsendbrief no. 70 nie.

Die onderverhaling is so groot dat dit nie vir verbruikers bekostigbaar gaan wees om 'n eenmalige verhoging in te stel nie. Die munisipaliteit is egter van voorneme om 'n prysstrategie te ontwikkel om die nodige verhogings met verloop van tyd op só 'n wyse in te faseer dat die impak op verbruikers versprei word.

Die munisipaliteit se 2014/15 begroting kom op R547 212 260 te staan, wat verteenwoordig word deur 'n kapitale begroting van R54 440 170 en 'n operasionele begroting van R492 772 090.





The Service Delivery and Budget Implementation Plans (SDBIPs) are detailed plans approved by the Mayor for implementing the municipality's delivery of municipal services and its annual budget.

- This SDBIP should include the following:
- Projections of each month
- Revenue to be collected, by source
- Operational and capital expenditure, by vote
- Service delivery targets and performance indicators for each quarter
- Any other matters prescribed

The Executive Mayor is expected to approve the SDBIP within 28 days after the approval of the budget. In addition the Executive Mayor must ensure that the revenue and expenditure projections for each month and the service delivery targets and performance indicators as set out in the SDBIP are made public within 14 days after their approval.

Water still healthy

Ontledingsverslae word op 'n maandelikse basis by hierdie suiweringsaanlegte deur 'n eksterne diensverskaffer, die SANS-geakkrediteerde A.L. Abbot and Associates, gedoen. Die mees onlangse verslag, saamgestel in April, gee 'n uiteensetting van die vyf dorpe se behandelde water en dui aan dat die water veilig is volgens die SANS 241-standaard, soos in die tabel.

It is important that treated water complies with the strict South African National Standards (SANS). Analysis reports are done on a monthly basis at these purification plants by an external service provider, the SANS accredited A.L. Abbot and Associates. The latest report, compiled in April, breaks down the five towns' treated water results and indicate the water results to be safe according to the SANS 241 standards as indicated in the table.




