Nanjengokuba ihlobo selidlule nokutshintsha kwemo yezulu sekuphezu kwethu, kukwanjalo nokufikelwa kwethu ngamnye namnye lixesha lokwenza uphawu lwethu kulonyulo oluzayo looMasipala baseMakhaya.

Unyulo kulindelek lwenzeke kwsithuba esithile esiphakathi kowe-18 kuMeyi (kwekaNcanzibe) kunye no- we-16 kuAgasti (kweyeThupha) kulo nyaka. Isizathu sokwenza oku sesokuba uzinyulele uceba ofunayo (ozakumela iwadi yakho) nozakuthabatha uxanduva ekulawuleni uMasipala waseLangeberg kule minyaka mihlanu izayo.

Ndibongoza bonke abahlali baqinisekise ukuba babhalisile; bayazi aphe bazakuvotela khona, kanan-jalo bakhuthaze nabanye boluntu lwabo ukuba bayo-kwenza ngokunjalo. Abavoti basenozikuqinisekisa ukuba babhalisile ngokuthi baye kwi-ofisi ye-IEC eku-futshane kubo. UkuNkezelu ngeenkonzo ezibalas-eleyo kuluntu lwethu yinto engaphakathi okanye ngumsebenzi ongundoqo wavo nawuphi na umasipa-la wasemakhaya kweli lizwe. Ngakooko xa umgangango-tho wokunikezela kwenkonzo ugcinwa uphezulu, ngo-ko nomngangatho wethemba loluntu kumasipala uts- ho uzikhulele futhi womelele.

Ndithanda ukubulela bonke abasebenzi, ooceba kunye neqela labalawuli bethu elihlakaniphileyo ngo-kuthi bazibonakalise kwakhona, ukuba uMasipala waseLangeberg ngomnye woomasipala abalawulwa ngendlela elungileyo kweli lizwe.

Ukuba ucinga kukuphela kweendaba ezakhayo le ngingqi enokunikezela ngazo, uMasipala waseLangeberg uthe kutshanje wabekwa kuluhlu njengomasipala wesithandathu olawulwa ngeyona ndlela apha eM-zantsi Afrika, ngokutsho kweSalathisi sikaRhulume-mente Sokusebenza luka2016. Esi salathisi siqulun-qwe ngaboLawulo Olulgileyo.

Siza kuqhubeleka sihambisa iinkonzo ezibalas-eleyo kwaye sisoloko sikulungele nokuphulaphula izid-ingo zoluntu lwethu. Siza kulenza lomelele ubambis-wano kunye namnye amanganaba karhulumente ku-nye nabo bachaphazelekayo nabafanelekileyo, khonkuze sidibene siyilwe lemiceli-mngeni, siqhube sibheke phambilis ngokwembumba.

Ambisieuse nuwe uitvoerende onderburgemeester vir streek!

Sy grootste passie is om 'n helpende hand aan die armste van armes te verleen. Dít is Zamikhaya Nyamana, wat onlangs in die Robertson-raadsaal verkies is tot die nuwe uitvoerende onderburgemeester van die Langeberg-munisipaliteit.

Nyamana (38), wat ook aangewys is as die portefeuillehoof van die departement van strategiese en ekonomiese ontwikkeling, sal vanuit 'n politiese oop-punt strategiese steun bied en 'n oorsig-rol vervul tot die einde van dié termyn.

"Ek wil die lewensgehalte van die mense van die Langeberg verbeter deur 'n resultaatgedrewe kultuur in my kantoor te skep wat floreer op effektiewe kommunikasie en spanwerk," het Nyamana gesê.

Sy kantoor het vennootskappe met verskeie relevante aandeelhouers in die gemeenskap as sleutelrol geïdentifiseer

om maatskaplike euwels in die gemeenskap aan te spreek. In samewerking met die polisie, departement van maatskaplike ontwikkeling en departement van onderwys, het Nyamana bygevoeg, sal hy graag programme wil uitrol wat uitdagings soos vroue- en kindermishandeling, dwelmmisbruik en misdaad aanspreek.

Nyamana is in 1976 in Tsomo in die Oos-Kaap gebore. Hy het op 'n jong ouderdom saam met sy gesin na Nkqubela verhuis waar hy in die Masakheke Ge-kombineerde Skool was. Hy is bekend as 'n mense-mens, goeie luisteraar en iemand wat altyd die ekstra myl sal loop.

Hy is 'n kanniedood Kaizer Chiefs- en Stormers-ondersteuner. Wanneer hy tyd op hande het, hou hy daarvan om op hoogte van die jongste nuus op plaaslike en internasionalevlak te bly.

Voorheen 'n petroljoggie by Robert-

son se Shell-vulstasie, het hy bewys dat 'n mens se omstandighede en agtergrond nie as 'n bepalende faktor in jou toekoms beskou kan word nie.

"Ek dink ek kan my vereenselwig met baie mense wat een of ander tyd in hul lewe moeilike tye moes oorkom. Ek hoop my verhaal kan ander in die gemeenskap inspireer om sukses te behaal, ongeag die striukelblokke in hul pad," het hy gesê.

Nyamana het sy oog nou ferm op die oorbrugging van grootskaalse kwessies wat honderde mense in die Langeberg-area direk raak. Werkloosheid, sê hy, is die grootste striukelblok wat die streek se groei en ekonomiese potensiaal lam-le, maar vaardigheidsontwikkeling onder jongmense, opvoeding en voldoende entrepreneurskap (plaaslike ondernemings) is ook sleutelkwessies wat dringende aandag vereis, aldus Nyamana.

"Om kragtige opvoedingsveldtogte

van stapel te stuur wat jongmense sal rig na kolleges vir verdere onderrig en opleiding en universiteit, moet ons kragte saamsnoer met die departement van onderwys en ander regeringsfere. Om 'n goeie fondament vir die streek se werkende populasie te lê is van kardinale belang. 'n Seker manier om sterk entrepreneursleiers te kry en meer plaaslike ondernemings te vestig, is om die masas op te lei.

Sportontwikkeling is nog 'n prioriteit vir die plaaslike leier. "Ek wil plaaslike sport sien floreer. Ons kan slegs gesamentlike oplossings vind tot dít wat verhoed dat plaaslike klubs nuwe hoogtes bereik, deur sterk vennootskappe te vorm," het hy gesê.

Volgens Nyamana is die Langeberg-muni-

sipaliteit 'n goedbestuurde instansie wat die afgelope vier jaar agtereenvolgens skoonoudits ontvang het en tens beskou word as een van die skoonste dorpe in die Wes-Kaap.

Hy benadruk dat, wanneer dit kom by dienslewering wat sigbaar moet wees, dit belangrik is om kwessies vinnig aan te spreek en om belastingbetalers te respekteer, om só gesamentlike vooruitgang te bewerkstellig.

Volgens Nyamana kan maatskaplike uitdagings nie deur 'n enkele persoon of entiteit opgelos word nie, maar deur forums, vennootskappe, oop gesprekke en ondersteuning van die gemeenskap.

"Ek gee diep om vir dié gemeenskap wat ons ons tuiste noem. Ek is gereed om die beste van myself aan die Langeberg te gee. Kom ons werk saam om 'n selfs mooier, veilige en produktiewe omgewing te skep."

His greatest passion in life is to lend a helping hand to the poorest of the poor.

This is Zamikhaya Nyamana, who has recently been elected inside the Robertson Council Chambers as the new Executive Deputy Mayor of Langeberg Municipality. Nyamana (38), who has been assigned as the portfolio head of the Department of Strategy and Social Development, will from a political vantage point provide strategic support and play an oversight role until the end of this term.

"I want to improve the quality of life among the people of Langeberg, by instilling a results-driven culture in my office which thrives on effective communication and teamwork," he said.

His office has highlighted "partnerships" with relevant stakeholders in society as the key ingredient for combating social ills experienced in this region.

Nyamana mentioned that in collaboration with the police, Department of Social Development and the Department of Education he would like to roll out programmes pinpointing challenges such as women and child abuse, drug-abuse and crime, and tackling them.

Born in 1976 in Tsomo in the Eastern Cape, Nyamana at a very young age relocated with his family to Nkqubela, where he attended Masakheke Combined School.

He is known to be a people's person, an effective listener and a person who will always go the extra mile.

He is a die-hard Kaizer Chiefs and

When he has some free time, he loves to keep abreast of the latest news and developments both locally and internationally.

Being a former petrol attendant at Robertson's Shell Garage he has proven that one's circumstances or background cannot be used as an indicator

to determine one's future.

"I think I can relate to many people who have had to endure tough times at some point in their lives," he said. "I hope my story can inspire others in our community to become successful, no matter what obstacles lay before them."

Nyamana has set his sights firmly

on overcoming large-scale issues that affect hundreds of people living in the Langeberg region directly.

He explains that unemployment is the single-biggest challenge crippling this region's growth and economic potential, but also highlighted skills development (youth), education, and inadequate entrepreneurs (local businesses) as key

issues that require urgent attention.

"To run powerful educational campaigns that will steer more young adults to FET colleges and universities, we need to collaborate with the Department of Education and other spheres of government. Laying a solid foundation for the region's working population is crucial. A certain way of getting strong entrepreneurial leaders and more local businesses being established is to educate the masses."

Sports development is another priority for the local leader. "I want to see local sport flourish. It's only by forming strong partnerships, can we begin to find common solutions to difficulties that are keeping our clubs from reaching new heights," he said.

According to him, the Langeberg Municipality is a well-run organisation that has for the past four years in a row achieved clean audits, and is currently regarded as one of the cleanest towns in the Western Cape.

He readily concedes that visible or discernible service delivery, prompt responsiveness, respecting the ratepayers are "essential in moving forward as a collective".

Nyamana stated that social challenges cannot be solved by a single person or entity, but through forums, partnerships, open discussion and support from the community.

"I care dearly for this community we call home. I'm ready to give the best of myself to Langeberg. Let's all work together to create and even more beautiful, safe and productive environment."

Lona nguMnu Zamikhaya Nyamana, othe wanyulwa kutshanje ngaphakathi Kwigumbi Lendibano yeBhunga eRobertson kule nyanga iphelileyo, njengoSekela Sodolophu weSigqeba omtsha kaMasipala waseLangeberg.

UNyamana (38), nothe wabelwa njengentloko yeSebe leQhinga no-Phuhliso Loluntu, uzakuthi ngengenelo lakhe kwezopolitiko anike inkxaso-qhinga kwananjalo adlale nendima yokongamela kude kufike isiphelo sexesa lakhe lobuceba.

"Ndifuna ukuphucula umgangatho wobomi phakathi kwabantu baseLangeberg ngokuthi nge-ofisi yam ndizise indlela yokusebenza engunozala weziphumo ntoleyeyakuchuma kuthethwano ngempumelelo kune nokusebenza njengeqela," utshilo.

I-ofisi yakhe ibalaselise "ubambiswano" kune nabachaphazelekayo ngokufanelekileyo eluntwini, nje neyona nto iphambili ekulweni iingxaki zentlalo ekugaxelekwa kuzo kulo

mmandla.

UNyamana uchaze ukuba ngentsebenziswano nabakwaSAPS, iSebe lo-Phuhliso loLuntu kune neSebe lezeMfundu angathanda ukuqalisia iinkqubo eizikungqala-nkqo ekuqu-bisaneni nemiceli-mngeni efana nokudlukunyezwa kwabasetyhini kune nabantwana, ukusetyenziswa gwenxa kweziyobi kwanobundlobongela.

UNyamana wazalwa ngo-1976 eT-somo kwelaseMpuma-Koloni. Ngexeshwa wayesemcinane kakhulu yena nosapho Iwakowabo bafudukela eNkqubela, apho ke wangena kwiSikolo Esidityanisiweyo saseMasakheke. Waziwa njengomntu wabantu, umntu okwaziyo ukumamel nowenza ade agqithise ukwenzela omnye umntu.

Ungumxhasi omkhulu waMakhosi neStormers.

Xa ethe wanexesa, uye athande ukuzigcina enolwazi ngeendaba nezinto eziqhubekeyo apha ekhaya nkwamany amazwe.

Nanjengamntu obekhe wasebenza njengomgaleli wamatfutha eenqwelo kwigaraji yakwaShell, eRobertson,

uyibonakalisile into yokuba iimeko opantsi kwazo okanye imvelaphi yakho ayisiso isibonakalisi esikhombisa ikamva likabani.

"Ndiyacinga ndingakwazi ukubonda abantu abaninzi ekufuneka banyamezele amaxesha anzima ngamathuba athile ebomini babo. Ndiyathembu ukuba ibali lam liyakuba nokukhuthaza abanye kulumu lwethu ukuze nabo baphumelele, kungakthaliseki nokuba yeyiphi imiqobo esendleleni yabo," utsho njalo.

UNyamana amehlo ache athe ntsho ekoyiseni imiba ngobabanzi yon ethi ichaphazele ngqo amakhulu-khulu abantu abahlala kulo mmandla was-eLangeberg.

Uye wachaza ukuba ukungabikho komsebenzi ngowona mnceli-mngeni umkhulu oqhawalelisa ukukhula kune nokuqaqamba kwezoqoqosho, kanye kwakhona wabalalelisa uphuhliso lwezakhona (kulutsha), imfundu kune nokunqongophala kosomashishini (osomashishini basekuhlaleni) njengento ephambili esadinga ukuni-kwa ingqalelo.

"Ukwenza amaphulo emfundu anefuthu nayakuthi aqhubele abantu abadala abasebatsha kwiiKholeji zokugqibezela imfundu naseziDyunesithi, kufuneka sisebenzisane kune neSebe lezeMfundu kwanamanye amanqanaba karhulumente. Ukubeka isisekelo esiluqilima kubemi bakulo mmandla abasebenzayo kubalulekile. Indlela ethile yokufumana iinkokheli ezimnqondo wazo ukwezoshishino nokuze kunmiselwe noosomashishini basekuhlaleni kufuneka kufundiswe nyambalala.

Uphuhliso lwezemidlalo yenye into eseqoka kule nkokheli yasekuhlaleni. "Ndifuna ukubona imidlalo yasekuhlaleni ihluma.

"Kuphela kungokusebenzisana ngamandla, apho khona sinokufumana izisombululo kubunzima athi azifumane ekuwo amaqela ethu nobuwa-thintela ekubeni ayokufikelela kumanqanaba aphezulu," uthethe wenjenjalo.

Ngokutsho kwakhe, uMasipala

waseLangeberg ngumbutho olawulwa ngendlela-entle othe kwiminyaka mine edlulileyo wafumana iingxelo zabapicotti ezingenachaphaza zilandelana, kwaye uthathwa njengenyeye-dolophu ezcocilekileyo eNtshona Koloni.

Uywabalaselisa isibakalo sokuba xa kufikelwa kunikeyelo Iweenkonzo njengento ebonakalayo, ukungelela ngoko nangoko kwimiba kwanokuhlonitshwa kwabarhafi "yeyona nto ibalulekileyo ukusiqhubela phambili njengembumba".

UNyamana uchaze nokuba imiceli-mngeni yasekuhlaleni ayingekhe ibe yinto esombululu ngumntu omnye okanye liqumrhu, kodwa ngeendibani-selwano, ngentsebenziswano, uthetha-thethwano oluvulelekileyo kune nnexaso evela kuluntu.

"Ndilukhathalele ngokwenene uluntu Iwasekhaya. Sendikulungele ukunikela ngobona mna eLangeberg. Sisonke masisebenzisane sikwenze kubekuhle ngakumbi okusinqongileyo, kuge kokukhuselekileyo kune nokunemveliso."



Budget Review 2016-'17

The Langeberg Municipality's budget tabled for the new financial year is presented against the backdrop of a weak global economy.

According to Ald. Diana Gagiano, Executive Mayor of the Langeberg Municipality, it is estimated that the next 24 months will be very difficult and challenging thus "visionary leadership is needed to steer us in the appropriate direction".

Gagiano stated that our currency has substantially depreciated against a basket of currencies in the world.

"There are a number of inflationary pressures in our economy like the current drought experienced in some parts of the country.

"Other pressures include high fuel, electricity and food prices, and the threat of the country being degraded into junk status by the rating agencies is another problem that will impact on our predicted growth of the economy," she said.

Another concern we must have is the high rate of unemployment which results in poverty.

The ultimate problem is that we will have more and more of our citizens being dependent on social grants and the Indigents Register will grow.

This will mean that more money will have to be allocated towards our Indigents Provision.


Pro-poor initiatives

In order to ensure that this municipality is a caring one that works for the poorest of the poor, we have drafted this budget in such a way that the impact of the bad economic climate does not negatively affect the most vulnerable groups of our society.

We have applied a combination of three strategies:

1. The value of properties to be exempted from property rates is R80 000 whilst legislation requires us to give R15 000 exemption.

2. The qualifying household income for indigent subsidy stays at R3 000 per household. Household implies the total

income of all persons who live on that property.

Note that the indigent grant will be withdrawn from any person who:

- Runs a spaza shop illegally from the premises receiving subsidy;
- Allows illegal electricity connections to the premises receiving an indigent grant;

- Subleases the premises receiving indigent grant which means that the applicant is not personally occupying the premises;

3. We have also introduced rates rebates to pensioners who are older than 60 years of age:

- For income of less than R3 000 per household the rebate is 60%.
- Household income of up to R5 000 per month will receive a 40% rebate.

Budget overview

The budget tabled for 2016-'17 is as follows:

The Municipality's 2016-'17 budget amounts to R696,287 million, made up as follows:

- Capital budget of R51,971 million;
- Operating budget of R644,316 million.

Revenue/tariff increases

- Tariffs for property rates will increase with 5,3%
- Electricity 7,64%
- The water increase will be 8,2%
- Solid waste 8,4%
- Sanitation 7,8%

Expenditure category increases

- Salaries and wages (including increments) 8,58%
- Repairs and maintenance 33,87%

Budget questions asked

Having regard for the economic crisis we find ourselves in, preparing the budget before us we had to ask ourselves a number of serious questions:

- How will it impact on the demand for municipal services by particularly companies and households? And how will this impact on municipal revenues and provisions for bad and doubtful debts?

- How will it impact on employment and household incomes within the municipal area? What impact will it have on the ability of ratepayers to pay, and therefore on the income of the municipality and provisions for bad and doubtful debts?

- Will there be an increase in the number of households that qualify to receive rates discounts and free basic services in terms of our indigent policy? How will this impact on the cost of providing these services, and what impact will it have on the sustainability of the municipality's finances?

- How will the scarcity of credit impact on the municipality's cost of borrowing? Will it increase the interest we have to pay on our existing debt? Will it affect the financial viability of using debt to finance planned capital projects? Will it be necessary for us to delay certain capital projects, such as the upgrade of electricity with which we are busy?





The Langeberg Municipality recently hosted its seventh annual career exhibition in Robertson, where learners took full advantage of the opportunity to consult with various tertiary institutions and FET colleges about their desired career path.

More than 1 000 learners, 50 parents and about 80 unemployed youth attended this year's two-day exhibition (Thursday 25 and Friday 26 February) at the Callie de Wet Hall.

Some of the institutions stationed inside the hall included the University of the Western Cape, Cape Peninsula University of Technology, Unisa, College of Cape Town, South African Police Service and PwC.

For the first time, the organisers of the exhibition invited local professionals such as doctors,

lawyers and accountants to engage with the region's top Grade 12 learners. The aim was for learners to gain first-hand insight into the career they would like to pursue after school.

The professionals explained to the learners what will be expected from them in the workplace, the pros and cons of the job, advised them, and also answered some of their burning questions.

The exhibition was hosted in partnership with the Department of Education (Worcester branch) and the Cape Career Exhibitors Association.

Dave van Schalkwyk, Manager: Social Development at Langeberg Municipality, mentioned that learners' futures begin at school. "This is where they should already be preparing and mapping out their future," said Van Schalkwyk.

He added that getting good results at school

will open doors further on in learners' careers.

Dave van Schalkwyk, bestuurder van maatskaplike ontwikkeling by die Langeberg-munisipaliteit, het genoem dat leerders se toekoms reeds op skool begin. "Dit is waar hulle reeds moet begin voorberei en hul toekoms beplan," het hy gesê. Hy het bygevoeg dat goeie prestasie op skoolvlak deure later

in hul loopbaan sal oopmaak.

"Jou toekoms is in jou eie hande. Maak seker dat wat jy gaan studeer werklik is wat jy wil doen wanneer jy kwalifiseer. Deur die verkeerde studierigting te kies, is nie net 'n vermorsing van kosbare tyd nie, maar ook kosbare hulpbronne. Dit is een van die hoofredes waarom ons jaarliks dié ekspo aangebied."

Van Schalkwyk het benadruk dat leerders, indien hul nie seker is wat hulle wil studeer nie, eers advies sal inwin voor hulle 'n finale keuse maak.

Ter afsluiting het hy gesê: "Ek wil, namens die Langeberg-munisipaliteit, ons opregte dank uitspreek teenoor alle kundiges wat tyd in hul besige skedules afgestaan het om die ekspo by te woon.

"Dit word baie waardeer."

Ezingcali zibachazela abafundi ngezinto eziyakulindeleka kubo xana bekwindawo zabo zokusebenza, izinto ezlungileyo nezingalunganga ngomsebenzi, babanika iingcebiso, kwakhona baphendula neminye yemibuso yabo etshisa ibunzi.

"Kulapha apho bamele ukuba sebesenza amalungiselelo behlahlela amakamva abo," utshilo uVan Schalkwyk.

Wongezelele ngelithi ukufumana iziphumo ezihihle esikolweni, kuya kuyivula ngakumbi iminyango emininzi kwikamva labo.

"Ikamva lakho lisezandleni zakho. Qinisekisa ukuba into ofuna ukuyifundela yilento kanye ufunu ukuyenza wakuba ugqibile.

"Ukukhetha ikhondo elingelilo lokufunda akwaneli nje ukuba likuchithele ixesa elibalulekileyo kodwa nelo lezbonelelo ezingabileyo. Esi sesinye sezizathu ezisenza sisingathe lemiboniso elekenyaka," uthethe wenjenjalo.

UVan Shalkwyk ugxininise kwinto yokuba "ukuba awuqinisekanga malunga nento ongathanda ukuyifundela, fumana iingcebiso phambi kokuba uthathe isiggibo sokuggibela".

Uvalelise ngelithi: "Ndingathanda ukuthetha egameni likaMasipala waseLangeberg, ndandise imibulelo yethu enzulu kuzo zonke iingcali eziithe zenza ixesa kwiishedyuli zazo ezixa-akekileyo ukuba bazokubalapha kwimiboniso yethu. Siyixabisile kakhulu lonto."



Our youth should be changing the world, not changing nappies

There are growing concerns within the Langeberg region that teenage pregnancy is now resulting in school dropouts.

The Provincial Department of Health's pregnancy statistics indicate that Langeberg has, since 2010, consistently recorded the highest rate of teenage pregnancies within the Cape Winelands region.

Over the past nine months 1 023 females gave birth in the Langeberg region. Of this number alone, 80 (7,8%) were teenagers.

The Langeberg Municipality has therefore noticed a need to conduct edu-

cational sessions about teenage pregnancy at schools.

The municipality has recently collaborated with the Western Cape Department of Education and Happy Valley Health Clinic, by hosting a teenage pregnancy educational session at Bonnievale Primary School. Only female learners from this school could attend the session.

The main purpose was to educate female learners about the importance of having respect for one's body, saying "NO", not compromising their schooling, and knowing that there are different methods of protection when engaging in sexual activity.

The programme also highlighted the importance of self-worth, personal empowerment, and laid emphasis on the potential consequences involved when engaging in sexual activity.

Dave van Schalkwyk, Manager: Social Development at Langeberg Municipality, mentioned that the best form of protection for young girls against unwanted pregnancies is abstinence.

"There are various methods of contraception, but it's never a certainty that you will be safe. There is also a strong possibility that you could contract a sexually transmitted disease, such as syphilis and Aids. Therefore practising abstinence is

always encouraged," said van Schalkwyk.

He added that all relevant stakeholders in society need to work together to address the rising number of teenage pregnancies in the region, as a matter of urgency.

Teenage pregnancy is one of the major contributing factors leading to poverty, health and social issues in the community.

Van Schalkwyk said a baby doesn't only has a financial impact on the family, but also has a massive emotional and psychological impact on a young mother. He added that there is a tendency for

young mothers to drop out of school, giving up their chance to educate themselves and pursue a profession. This decision could impact negatively on the child's well-being.

Learners were also informed that support is freely available at their nearest clinic. They can get contraception, family planning advice, a pregnancy test, counseling and referrals for an abortion as well as screening and treatment for sexually transmitted illnesses and HIV/Aids.

Wongeza esithi kukho nomkhwa womama abasebatsha abashiya isikolo, banikezele ngamathuba abo okufundela umsebenzi othile. Esi sigqibo singasichaphazelakakubi intlalontle yomntwana.

Ons jeug moet die wêreld verander, nie doeke ruil

Kommer neem toe in die Langeberg-streek dat tienerswangerskappe ál meer tot skoolverlating lei.

Die provinsiale gesondheidsdepartement se statistieke ten opsigte van swangerskappe toon dat die Langeberg sedert 2010 die hoogste vlakte van tienerswangerskappe in die Kaapse Wynland-distrik gehad het.

Gedurende die afgelope nege maande het 1 023 geboorte geskenk in die Langeberg-area. Hiervan alleen was 80 (7,8%) tieners.

In die lig hiervan het die Langeberg Municipaaliteit die nood geïdentifiseer om inligtingsessies ten opsigte van tienerswangerskap by skole aan te bied.

Die munisipaliteit het onlangs kragte saamgesnoer met die Wes-Kaapse departement van onderwys en die Happy Valley-gesondheidskliniek om 'n tienerswangerskap-inligtingsessie by die Bonnievale Primêre Skool aan te bied. Slegs meisies van die skool is toegelaat om die sessie by te woon. Die hoofdoel van die sessie was om aan meisies te beklemtoon dat dit be-

langrik is om respek vir jou liggaam te hê, om "NEE" te sê, nie hul geleentheid op onderrig in gedrang te bring nie en te weet dat daar verskeie beskermingsmaatreëls is as hulle seksueel aktief is.

Dave van Schalkwyk, bestuurder van maatskaplike ontwikkeling by die Langeberg Municipaaliteit, het benadruk dat die beste vorm van beskerming teen ongewensde swangerskap vir jong meisies onthouding is.

"Daar is verskeie metodes van voorbehoeding, maar dit is nooit 'n waarborg dat jy veilig sal wees nie. Daar is ook 'n sterk moontlikheid dat jy 'n seksueel oordraagbare siekte soos sifilis of vigs kan opdoen, dus word onthouding altyd aangemoedig," het hy gesê.

Van Schalkwyk het bygevoeg dal alle relevante rolspelers in die samelewning moet saamwerk om die stygende voorkoms in tienerswangerskappe in die streek as 'n saak van dringendheid aan te spreek.

Tienerswangerskappe is een van die

grootste bydraende faktore tot armoede en gesondheids- en maatskaplike kwessies in die gemeenskap. 'n Baba, het Van Schalkwyk gesê, het nie net 'n finansiële impak nie, maar ook 'n reuse emosionele en sielkundige impak op 'n jong ma.

Daar is 'n geneigdheid onder jong ma's om hul skool te verlaat, aldus Van Schalkwyk, wat daartoe lei dat hulle hul kans op geleerdheid en geleentheid om 'n loopbaan na te jaag, prysgee. Dié besluit kan 'n negatiewe impak op die kind se welstand hê.

Leerders is ook ingelig dat ondersteuning gratis by hul naaste kliniek beskikbaar is. Hulle kan voorbehoeding, gesinsbeplanningsadvies, swangerskaptoetse, berading en verwysing vir aborsië sowel as toetse en behandeling vir seksueel oordraagbare siektes en MIV/vigs ontvang.
