# Stray Animals

**The big debate of Langeberg's stray animals has come into sharp focus after a recent incident took place involving a vehicle crashing into a cow along the R60.**

Cattle can often be seen roaming right next to main roads in and around Langeberg, grazing scarcely close to incoming and outgoing traffic. This has sparked a debate which now has everyone guessing: who is responsible for stray animals?

After the judgement on the Pounds Ordinance by the Eastern Cape High Court, the Western Cape Department of Local Government developed a Draft Standard By-Law on Pounds together with its legal services team.

The Eastern Cape High Court declared the Pounds Ordinance, same one which was used by the Western Cape, to be unconstitutional. Therefore Western Cape Department of Local Government decided to create a Draft By-Law on this subject.

This By-law is part of the rationalisation of old ordinances which the Department is busy with. A municipality may adopt the Draft Standard By-Law on Pounds as it is or with amendments following its By-Law development which includes an extensive public participation process.

However, a further complication with the implementation of the Draft By-Law and the ruling of the Constitutional Court is the fact that most of the stray animals are not branded. This makes it difficult to identify the owner/s and to give proper notices as envisaged in the By-Law.

The Agricultural Act requires that animals must be branded. The enforcement of this legislation is vital in the management of stray animals.

It is with these provisions in mind that the municipality maintains that the management of stray animals is a complicated matter and requires full cooperation from the other spheres of government.

According to the draft By-Law, the following applies when considering the seizure of animals for impoundment:

- A lost, abandoned, stray or trespassing animal, or an animal that is not kept under proper control by its owner, and that is found in a public place or on private land, may be seized and delivered to a pound for impoundment.
- In the case of an animal that is found in a public place, the following persons may seize the animal: member of SAPS; member of the SANDF; law enforcement officer or the provincial department responsible for road traffic matters; an authorised official of the municipality; a pound keeper; an employee of any Society for the Prevention of Cruelty to Animals

located in the Province; or any other person determined by the municipality from time to time.

In the case of an animal that is found on private land, the animal may be seized by the owner or occupier of that land. Alternatively, one of the authorised officials may seize the animal too.

The person who seizes the animal must deliver it to the nearest accessible pound, taking the shortest practical route and within the shortest practical time.

The owner of the animal will be held liable for costs incurred by ratepayers. However, the owner will be given seven days to dispute those fees and reasonable expenses.

A pound keeper must, within seven days of the impoundment of an animal, notify the owner. A statement should also be issued by the pound keeper to the owner stating that he or she has seven days, calculated from a date stipulated in the notice, to dispute those fees and reasonable expenses.

If the owner does not dispute the fees and reasonable expenses, but fails to pay by the given date, the pound keeper will then apply to a magistrate's court for an order authorising him or her (pound keeper) to sell the animal.

Currently, Langeberg Municipality does not have a Pound. However, it makes use of the Pound in Swellendam.

- Malunga nesilwana esifunyenwe kwindawo kawonke-wonke, aba bantu balandelayo banokusithata isilwanyana: Ilungu lamaPolisa, iJoni, iGosa elinyanzelisa umthetho okanye Isebe lePhondo elijongene nemibandela yezendlela, iGosa eligunyazisiweyo likamasipala, uMgcini weskithi, umsebenzi wombutho okhusela ukuphathwa kakubi kwezilwanyana kwiphondo, okanye nawuphina omnye umntu omiselwe ngumasipala kumaxesha ngamaxesha.

Malunga nesilwana esifunyenwe kumhlaba wabucala, eso silwanyana sinokuthathwa ngumnini mhlabu okanye lomntu ohlala kulomhlaba. Ngapha koko, nawuphi na kumgosa agunyazisiweyo nawo asenokusithatha eso silwanyana. Umntu othatha isilwanyana umele asise kwiskithi esikufutshane nesfikelekayo esebezisa eyona ndlela emfutshane kangangoko kunokwenzenka nangexesha elifutshane kangangoko kunowenzeka.

Umnini-silwanyana ubophelelekile ukuba ahlawule iindleko zabarhafi. Noko ke, umnini-silwanyana uyakunikwa iintsku ezsixhenxe ukuba aphikise iintlalwulo kwakunye kwanokufaneleka kweezondleko.

Umngcini wesikithi umele, kwiintsuku ezsixhenxe emva kokuvalwelwa kwezilwanyana amazise umninizo. Umgcini weskithi umele akhuphe isaziso samaxabiso aze achazele umninizo ukuba uneentsku ezsixhenxe ukususela kumhla wesazisi sokuba aphikise ukufaneleka kweentlawulo kunye neendleko eziqulethwe kwesi saziso.

Ukuba umnini-zilwanyana akaziphikisi iintlalwulo neendleko ezifanelekiyo, kodwa asilele ukuzihlawa ngomhla obekiweyo, umgcini weskithi umele enze isicelo kwinkundla kamantyi ukuba akhuphe umyalelo wokumgunyazisa ukuba asithengise isilwanyana eso. Okwangoku, umasipala waseLangeberg awunayo indawo yokuvalela izilwana (Iskithi). Kodwa ke usebenzisa esaseSwellendam.

# Rondloperdiere

Die debat oor Langeberg se rondloperdiere het weer in fokus gekom na 'n ongeluk op die R60 waarin 'n voertuig met 'n koei gebots het.

Vee kan dikwels langs die hoofpaaie in en om Langeberg gesien word, waar hulle naby inkommende en uitgaande verkeer wei. Dit het aanleiding gegee tot 'n debat waar almal nou raai: wie is verantwoordelik vir rondloperdiere?

Ná die uitspraak oor die Skut-Ordonnansie deur die Oos-Kaapse Hooggereghof, het die Wes-Kaapse Departement van Plaaslike Regering met sy regsdienste-span 'n Konsep-Standaardverordening op Skutte ontwikkel.

Die Oos-Kaap Hooggereghof het verklaar dat die Skut-Ordonnansie, dieselfde een wat deur die Wes-Kaap gebruik is, ongrondwetlik is. Daarom het die Wes-Kaap Departement van Plaaslike Regering besluit om 'n Konsepverordening oor hierdie onderwerp te skep.

Hierdie Verordening is deel van die rasionalisering van ou ordonnansies waarmee die Departement besig is. 'n Munisipaliteit kan die Konsep-Standaardverordening op Skutte aanvaar soos dit is, of met wysigings na aanleiding van sy verordening-ontwikkeling wat 'n uitgebreide openbare deelnameproses insluit.

'n Verdere komplikasie met die implementering van die Konsep-verordening en die uitspraak van die Konstitusionele Hof is egter dat die meeste van die rondloperdiere nie gemerk word nie. Dit maak dit moeilik om die eienaars te identifiseer en behoorlike kennisgewings te gee soos beoog in die Verordening.

Die Landbouwet vereis dat diere gemerk moet word. Die handhawing van hierdie wetgewing is noodsaklik in die bestuur van rondloperdiere.

Met hierdie bepalings in gedagte hou die munisipaliteit vol dat die bestuur van verdwalende diere 'n ingewikkeld aangeleenthede is en dat dit volle samewerking van die ander regeringsfere vereis.

Volgens die Konsepverordening is die volgende van toepassing wanneer diere vir beslaglegging oorweeg word:

- 'n Verlore, verlate, rondlopende of oortredende dier, of 'n dier wat nie behoorlik beheer word deur sy eienaar nie en wat in 'n openbare plek of op privaatgrond aangetref word, mag in beslag geneem word en aan 'n skut gelewer word.

- In die geval van 'n dier wat in 'n openbare plek aangetref word, kan die volgende persone die dier aanneem: lid van die SAPD; lid van die SANW; wetstoepassingsbeampte of die provinsiale departement verantwoordelik vir padverkeers-aangeleenthede; 'n gemagtigde beampte van die munisipaliteit; 'n skutbewaarder; 'n werknemer van enige Diere Beskermingsvereniging in die Provincie; of enige ander persoon wat van tyd tot tyd deur die munisipaliteit bepaal word.

In die geval waar 'n dier op private grond gevind word, kan dit deur die eienaar of okkuperer van die grond beslag gelê word. Alternatiewelik kan een van die gemagtigde beamptes ook die dier vang.

Die persoon wie die dier vang moet dit aan die naaste toeganklike skut lever, met die kortste praktiese roete en binne die kortste praktiese tyd.

Die eienaar van die dier sal aanspreeklik gehou word vir koste aangegaan deur belastingbetalers. Die eienaar sal egter sewe dae gegee word om daardie fooie en redelike uitgawes te betwis.

'n Skutbewaarder moet, binne sewe dae na beslag op die dier gelê is, die eienaar van die dier in kennis stel. 'n Verklaring moet ook deur die skutbewaarder aan die eienaar uitgereik word waarin verklaar word dat hy of sy sewe dae, bereken vanaf die datum soos in die kennisgewing bepaal, het om daardie fooie en redelike uitgawes te betwis.

Indien die eienaar nie die fooie en redelike uitgawes betwis nie, maar versuim om te betaal teen die gegewe datum, sal die skutmeester by 'n landroshof aansoek doen om 'n bevel wat hom of haar (skutmeester) magtig om die dier te verkoop.

Huidiglik het Langeberg Munisipaliteit nie 'n skut nie. Dit maak egter gebruik van die skut in Swellendam.



# ASHBURY LIBRARY

**Where there once was nothing, a beautiful library to the value of R6.1 million now stands proudly in the Ashbury community.**

Construction works are now complete and the finishing touches, from furniture to internet access, is now being finalised to ensure everything is perfect for the official opening.

Ashbury library will officially be opened with a formal inauguration ceremony by the Western Cape Minister of Cultural Affairs and Sport, Ms Anroux Marais, in June 2017

Although the library is not yet operational, the community can start to take ownership of the building so that it will not become prone to vandalism. Everyone is welcome to go and view the exciting new building and the services that will soon be on offer. The library is open from 09:00 – 18:00 (Mondays to Fridays). Residents are encouraged to collect an application form and become a member of the library, free of charge.

Christa Joubert, Librarian at Langeberg Municipality, mentioned that library staff are currently reading stories to the young children and teaching them about

library etiquette. School children are also welcome to come and sit in the library to do homework.

She added that this facility will serve almost 10 000 people. "Previously, kids, adults and the elderly living in Ashbury used to walk far distances to have access to a library. This facility is quite central to all citizens living in the Ashbury area," said Joubert.

The library will be equipped with the following:

# Langeberg hosts its first disability program

**"We can only imagine how much of yourself you give on a daily basis to make a disabled person's life a little bit more comfortable and pleasant. Thank you!"**

So says Madelain van der Berg, Development Officer at Langeberg Municipality, who expressed the important role that carers play in the lives of the disabled within the Langeberg region.

Langeberg Municipality has for the first time hosted a Disability Program, in

partnership with Cape Winelands District Municipality, Breede River Hospice and Western Cape Department of Health.

More than 100 carers from different towns attended the program which was held at the Ashton Town Hall earlier this month.

Carers usually work several hours per day and put lots of strain on their bodies which can lead to stress. It's also common for carers not to have adequate time to relax and spend time alone.

A few specialists from Robertson Hospital Magda Du Preez (Physiotherapist), Rianri

Bester (Occupational Therapist), Nuraan Leeman (Mouth Hygienist) and Leana Lubbe (Dietician) shared their expertise with the carers on a range of topics.

Du Preez demonstrated to the carers how to move disabled people on a bed or in a wheelchair without causing strain to their backs or necks.

Bester gave carers a crash course in how to deal appropriately with stress and provided them with effective relaxation techniques.

Leeman said carers should check their patient's mouth twice a day to ensure proper hygiene. Leana Lubbe (Dietician)

shared information on dealing with a patient who suffers from constipation.

Arzalia Wantza, Development Officer at Langeberg Municipality, delivered a warm thanks to all the role players for making this program a success.

She also had this to say in conclusion: "The daily work that caretakers put in to help another human being is priceless. We plead to all family members of a disabled person or patient to assist the carer with emotional support, giving them adequate breaks and maybe a gift from time to time to say 'thank you.....we appreciate you'".



Langeberg Municipaaliteit het vir die eerste keer 'n Gestremdheidsprogram aangebied, in samewerking met Kaap-Wynlandse Distrikmunicipaliteit, Breederivier Hospice en die Wes-Kaap Departement van Gesondheid.

Meer as 100 versorgers van verskillende dorpe het die program bygewoon wat vroeër hierdie maand in die Ashton stadsaal gehou was.

Versorgers werk gewoonlik 'n paar uur per dag en sit baie spanning op hul liggeme wat tot stres kan lei. Dit is ook algemeen dat versorgers nie genoeg ontspanningstryd het en tyd het om alleen te spandeer nie.

'n Paar spesialiste van Robertson Hospitaal, Magda Du Preez (Fisioterapeut), Rianri Bester (Arbeidsterapeut), Nuraan Leeman (Mondhigiënis) en Leana Lubbe (Dieetkundige) het hul kundigheid op

'n verskeidenheid onderwerpe met die versorgers gedeel.

Du Preez het aan die versorgers gedemonstreer hoe om gespas met stres te werk en het hulle van effektiewe onspanningstegnieke voorsien.

Leeman het gesê dat versorgers hulle pasiënte se monde twee keer per dag moet nagaan om behoorlike higiëne te verseker. Leana Lubbe het inligting gedeel oor hom om 'n pasiënt te hanteer wie aan hardlywigheid ly.

Arzalia Wantza, Ontwikkelingsbeampte by Langeberg Municipaaliteit, het 'n warm dankbetuiging aan al die rolspelers gelewer wie die program 'n sukses gemaak het.

Sy het ook die volgende gesê in haar afsluiting: "Die daagliks werk wat versorgers insit om 'n ander mens te help, is onskatbaar. Ons pleit aan alle gestremde persone of pasiënt se familie is om die versorger met emosionele ondersteuning te help, om hulle voldoende ruskans te gee en dalk van tyd tot tyd 'n geskenk om dankie te sê... ons waardeer jou."

# **Massive water reservoir being built in Nkqubela**

**One of Langeberg Municipality's 2017-2018 capital projects titled 'Construction of a 3.0ML Water Reservoir' is currently being built in Nkqubela.**

This project, valued at R27.661 million, will be implemented in two phases. The first phase would include the building of the reservoir, pump station and laying down the pipes. Phase 2 of the project will solely focus on enclosing the area with fencing.

The reason behind the construction of a Water Reservoir is to ensure the

sustainability of water supply to the surrounding community. Most areas in Robertson receive their water supply from the Robertson Treatment Works. And Nkgubela is no exception.

Maynard Johnson, Manager: Civil Engineering at Langeberg Municipality, mentioned that approximately 20 temporary jobs (9 month period) have been created for the duration of this project.

The project is expected to be completed by December this year.

## WATER SAVING TIPS



- Turn off running taps while washing your face, brushing teeth, shaving and washing dishes.
- Fix leaks in taps, pipes and toilets
- Properly close taps



- Limit your shower to five-minute or less
- Close the tap while soaping up



- If you prefer to bath, share bath water, and don't make it as full. Taking a bath could use between 80 and 150 liters of water.
- Re-use bath water in the garden or to flush a toilet.




- Install a water-saving toilet flush system: Insert a 2-liter bottle, filled with water, into the toilet cistern.
- Fix leaking toilets.
- Avoid flushing the toilet unnecessarily.




- Don't over-fill containers for cooking.
- Every time you boil an egg, save the cooled water for your houseplants. They'll benefit from the nutrients released from the shell.



- Do not pollute water by pouring chemicals down the drain.



- Use "grey water". Re-used water from baths, shower, washing machines and other safe sources
  - to flush your toilet
  - to water your garden



- Do not over-fill or excessively backwash your swimming pool.
- Use a pool cover and pump used pool water to the garden.



- Use a bucket rather than a hose to wash your car.
- If you must use a hose, use a sprayer that can be turned off in-between spraying the car.



- Water gardens less frequently, but water well.
- Always water your plants at night



- Focus on indigenous and non-waterconsumptive alien plants (but not invasive alien plants).
- Group plants according to their water needs.
