# Brand new Traffic Office for Ashton

Construction of Langeberg Municipality's new Traffic Office building in Abattoir Road, Ashton is now complete, seven months after the project started in April 2018.

It is estimated that the Ashton Traffic Office renders traffic services to approximately 2 000 members of the public on a monthly basis. The constant influx of clients to the traffic office resulted in the dire need to create

additional office space.

Staff will soon occupy the brand-new building, and their new working environment will undoubtedly ensure delivery of more professional and efficient traffic services to the public.

The new building comprises a reception area, a learner driver testing venue, three new personnel offices and a waiting room area for the public. The total cost amounts to approximately R2,7 million.

**Services available at the Ashton Traffic Office include:**

- Roadworthy tests and licences
- Issuing of learner/driver licences
- Issuing of disks to indicate passengers with disabilities
- Processing applications for driving instructor certificates
- Driver licence card renewals
- Motor vehicle registrations
- Professional driver's permits

- NATIS transactions
- Enquiries

The project also greatly benefitted the area by creating jobs. "It is satisfying that all architectural fees, engineering fees, material costs and the majority of the labour costs were paid to companies and persons living within the Langeberg Municipality," said Neil Albertyn, Manager: Project Management.

## Nuwe verkeerskantoor in Ashton nou oop

Die konstruksie van Langeberg-munisipaliteit se nuwe verkeerskantoor in Abattoirweg, Ashton is voltooi – sewe maande nadat die projek in April 2018 begin is.

Na raming hanteer die verkeerskantoor ongeveer 2 000 kliënte op 'n maandelikse basis. Dié toename van kliënte het daar toe gelei dat 'n nuwe kantoorruimte geskep moes word.

Die personeel gaan binnekort die nuwe kantoor gebruik wat tot beter en meer doeltreffende dienslewering aan die publiek lei.

Die nuwe gebou bestaan uit 'n ontvangs, 'n lokaal vir leerlingbestuurders, drie nuwe personeelkantore en 'n wagkamer vir die kliënte. Die totale koste van die projek het ongeveer R2,7 miljoen beloop.

# Traders receive equipment to boost businesses

Informal and micro-enterprise traders from the Langeberg area received essential equipment as part of the Small Enterprise Development Agency's (Seda) Informal and Micro Enterprise Development Programme (IMEDP) on 12 October 2018.

The equipment will assist these entrepreneurs in boosting their businesses.

For the first handover, the programme focused specifically on catering businesses. Other qualifying beneficiaries in the Langeberg area will be assisted early next year.

The IMEDP currently provides a 100% equipment grant to informal and micro-businesses, with grants

ranging from R500 to R9 000. Equipment received by Langeberg's beneficiaries included gas and electric stoves, bar fridges, and chest freezers.

IMEDP is a programme that targets informal and micro-enterprises, prioritising women, youth and people with disabilities who own businesses based in townships, rural areas, mining towns and cities.

The scheme offers an all-inclusive package, which includes training, tools, equipment and mentorship.

Applications for the IMEDP follow a rigorous adjudication process, in which qualifying criteria were verified and all

required documents scrutinised for validity at Seda's provincial offices. A final list of qualifying beneficiaries is then selected and sent to the National Office for final selection and adjudication.

IMEDP verskaf tans 'n 100%-toelaag vir toerusting vir informele- en mikro-ondernehemings met toelae wat wissel van R500 tot R9 000.

Toerusting wat die begunstigdes ontvang het, sluit gas- en elektriese stowe, kroegskassies en kisvrieskaste in.

IMEDP is 'n program wat op die informele en mikro-ondernehemings fokus waar vroue, jongmense en mense met gestremdhede voordeel word met sakeondernemings in woonbuurte (townships), afgeleë gebiede, myndorpe en stede. Dié program sluit alles in, van opleiding, toerusting, gereedskap tot mentorskap.

# Quench this summer's heat at the swimming pool

The Robertson Swimming Pool will once again welcome hundreds of visitors during this predicted very hot summer season. The pool provides a large lawn space to relax and enjoy picnics as well as seven braai spots to use on a first-come, first-serve basis.

It is important to note that the pool can reach its full capacity of 432 swimmers at any given time. So rather be an early bird to avoid disappointment.

Daily operational hours are from 10:00 to 18:00 on Mondays to Saturdays, and from 12:00 to 18:00 on Sundays. The current daily entrance fee is R26 per adult and R17 per child. Also available are season tickets at R362 and monthly tickets at R213.

Security guards have been appointed to ensure the safety of visitors over weekends and special holidays, but use of the swimming pool area is at one's own risk. To have fun and be safe, we advise visitors who are eager to relax at the poolside to familiarise themselves with the rules of the facility.

Kindly note that only people wearing swimming costumes will be allowed into the pool. Nobody will be allowed to swim in clothes, jeans, T-shirts or underwear.

#### DON'TS

- No alcohol is allowed on the premises
- No unnecessary or excessive noise is permitted
- No pushing people in and around the pool

- No running around the pool
- No rough playing on the premises
- No diving into the shallow side of the pool
- Do not swim alone
- Do not use the pool as a toilet
- Do not swim if you have a gastrointestinal (stomach) upset or skin or respiratory infection

#### DO'S

- Report any bad behaviour
- Report vandalism
- Clean up after yourself
- Call for help if you notice someone drowning
- Be considerate of others and your surroundings
- Look out for yourself and other swimmers
- Always swim within your ability
- Check the depth where you can comfortably swim
- Shower before you swim
- Wear appropriate sun screen protection
- Have fun and be safe

# Fire season is approaching

Summer brings longer days and warmer temperatures, but unfortunately also the imminent danger of veld fires. During the hot and dry summer season fires are more prevalent and difficult to control. To help you be better prepared, it is important to have a good understanding of veld fires.

Veld fires are a major hazard in the Langeberg municipal area and have the potential to develop quickly into a disaster or catastrophic situation. A serious matter of concern is the fact that fire seasons are growing longer and high fire-risk days are getting more. Owing to intense heat as well as windy, dry conditions the Langeberg municipal area normally experiences most fires between November and March.

Most fires are caused by negligence or a lack of concentration. Cigarettes, braai fires, matches, lighters, candles and heating appliances can all be lethal, if not carefully used and monitored. The Langeberg Municipality urges residents and visitors to the area to be vigilant and cautious when dealing with fire.

**Currently the main reported causes and reasons for the spread of veld fires are the following:**



- Runaway prescribed burns, for example, when landowners lose control in creating firebreaks, including other prescribed burning operations, especially on high fire danger index days;
- Ignitions due to negligent treatment of picnic, cooking or warming fires;
- Runaway fires due to the ignition of informal refuse sites, including the burning of compost heaps;
- Lightning;
- Tools and appliances used in an unsafe manner;
- Lack of fire breaks;
- Overgrown road reserves, and
- Arson.

**To prevent fires, please ensure the following:**

- Make sure braai fires and warm coals area extinguished when leaving the area, either with sand or water;
- Make sure there are no illegal electrical connections in your immediate area;
- Do not play with matches;
- Do not burn rubbish on windy days;
- Do not throw cigarette butts out of your car window;
- Do not leave fires unattended, and
- Keep your property clean and safe – this includes cutting your grass and performing regular maintenance checks.

Your assistance is of vital importance to combat fires in our area. In the event of a fire outbreak, report the fire immediately, even if it seems small.

## Brandseisoen op hande

Met die somer is die dae nie net langer en die temperature hoër nie, maar veldbrande is ook aan die orde van die dag. In die warm, droë somerdeae kom brande meer dikwels voor en raak dit ook makliker buite beheer. Om jou te help om voorbereid te wees, is dit belangrik om meer oor veldbrande te weet.

Veldbrande is 'n groot probleem in die Langeberg-munisipale gebied en dié brande kan maklik in 'n ramp verander. Een van die grootste bekommernisse is dat die brandseisoen al hoe langer word. As gevolg van die warm, droë winderige toestande in die Langeberg-munisipale gebied vind die meeste veldbrande tussen November en Maart plaas.

Die meeste brande word deur agterlosigheid en 'n tekort aan konsentrasie veroorsaak. Sigaretstompies, braaivleisvure, vuurhoutjies, aanstekers, kerse en verhittingstoestelle kan alles dodelik wees as dit nie gemonitor en verantwoordelik gebruik word nie. Die Langeberg-munisipaliteit moedig inwoners en besoekers aan om verantwoordelik op te tree wanneer hulle met vuur werk.

**Die algemene redes vir die verspreiding van veldbrande is:**

- Wegholbrande wat deur byvoorbeeld 'n kortsluiting in 'n grassnyer veroorsaak word wanneer daar gras gesny word wanneer dit

**hoëbrandgevaarde is;**

- Op 'n nalatige wyse braaivleisvure aansteek of vuur maak om kos te maak of om jouself warm te hou;
- Wegholbrande wat veroorsaak word wanneer afval of komposhope gebrand word;
- Weerlig;
- Gereedskap en elektriese toerusting wat nie veilig gebruik word nie;
- 'n Tekort aan brandstroke;
- Toegroei van padreserwes;
- Brandstigting.

**Om brande te voorkom:**

- Maak seker dat braaivleisvure of warm kole dood is voor jy die gebied verlaat. Braaivleisvure of kole kan met sand of water geblus word;
- Maak seker daar is nie onwettige elektriese verbinding in jou omgewing nie;
- Moenie met vuurhoutjies speel nie;
- Moenie vullis in winderige dae brand nie;
- Moenie sigaretstompies uit die venster goo nie;
- Moenie vure alleen los nie
- Sorg dat jou eiendom skoon en veilig is, dit sluit in sny jou gras gereeld en onderhou jou tuin.

Die inwoners se samewerking is baie belangrik om brande in die omgewing te voorkom. Wanneer daar 'n brand uitbreek, meld dit onmiddellik aan.

## A century later – The Great Flu Epidemic remembered

One hundred years ago this month, the Great Flu Epidemic of 1918 swept across the globe.

South Africa was the fifth most affected country in the world, with 500 000 deaths. Altogether 62% of those who died, lived in the Cape.

The Langeberg was not exempted. In Montagu, the deceased were buried in the south-eastern corner of the Dutch Reformed Church property, corner of Bath and Bloem Street.

During 1960/1961 the previous Montagu Municipality undertook a project to upgrade and widen Bloem Street. A portion of the Dutch Reformed Church property, running the length

of Bloem Street, was expropriated for this purpose.

During the excavation phase the contractor came upon the remains of those who had died during the Great Flu Epidemic. The construction work was immediately halted by Dr Charlie Muller, while the ground was disinfected.

All the remains were then exhumed and placed in a specially built crypt in the Old Montagu Cemetery.

On 22 November 2018 a plaque was unveiled in Bloem Street by the Executive Mayor, Alderman H. Jansen, to commemorate the centenary since the tragedy occurred.
