# New housing project for Nkqubela

Construction has begun on the Erf 136 Housing Project in Nkqubela. The project, which was approved by The Department of Human Settlements (Western Cape), will see the building of 172 standard RDP houses.

The cost of the project is estimated at R11.7 million and forms part of Langeberg Municipality's capital projects for 2019-20.

"At present we are busy with the upgrading of the roads and stormwater of Erf 136, from a B to an A grade," said Mr Jacobus Jooste, Acting Manager: Housing Projects.

"The process entails the tarring of gravel roads in the area. The project is in our capital budget for 2019-20, but we may well start earlier."

Beneficiaries of the RDP houses will be people who qualify for a subsidy and are on the Housing Waiting List for Nkqubela.

There is only one consolidated waiting list for the Langeberg municipal area, on which 9 692 people are currently registered.

All allocations are done according to the date of application.

To be eligible for prospective housing projects one must be registered on the Langeberg Housing Database.

#### How to register

Complete the application form for Housing Assistance/Accommodation, and hand it in at your nearest housing office. The form can be collected from your nearest housing office.

To qualify to be placed on the database, you must be:

- a South African citizen or be in possession of a permanent residence permit;
- over the age of 18;

- married or cohabiting, and is not the owner of a property;
- single or divorced, with proven financial dependants permanently living with you (this is not applicable if you have a disability or are over the age of 60);
- legally competent to sign a contract;
- an individual who has not been

- a beneficiary of a government housing subsidy; and
  - the recipient of a gross monthly income (with your spouse/partner) that does not exceed R3 500 per month (before deductions)
- You need to submit:
- a certified copy of your ID;
  - a certified copy of your spouse's ID, if applicable;

- certified copies of your children's birth certificates, if applicable; and
- certified copies of marriage or divorce certificates.

# Nuwe behuisingsprojek vir Nkqubela

Bouwerk aan die ERF 136-behuisingsprojek in Nkqubela het begin.

Dié projek, wat deur die departement van menslike nedersettings (Wes-Kaap) goedgekeur is, behels die bou van 172 standaard HOP-huise. Die koste van dié projek word op R11,7 miljoen geraam en vorm deel van die Langeberg-munisipaliteit se kapitaalprojekte vir 2019-'20.

"Ons is tans besig met die upgradering van die paaie en stormwaterstelsel van ERF 136 om dit van 'n B- na 'n A-graad op te gradeer. Die proses behels die teer van grondpaaie in die omgewing. Die projek is op ons kapitaalbegroting vir 2019-'20, maar dit is moontlik dat ons vroeër sal begin," het mnr. Jacobus Jooste, waarnemende bestuurder vir behuisingsprojekte, gesê.

Die begunstigdes van HOP-huise sal mense wees wat vir 'n subsidie kwalifiseer en wat op die

behuisingswaglys vir Nkqubela geregistreer is.

Die Langeberg-munisipale gebied het slegs een gekonsolideerde waglys waarop 9 692 mense tans geregistreer is. Alle toekennings word volgens die aansoekdatum gedoen.



# Misused skips removed

The skips placed in residential areas by Langeberg Municipality to create a central point for collecting garden waste were removed due to the skips being misused. Instead of using the skips for garden waste as intended, perpetrators used it to dump household and other waste, in and around it, illegally. This defeated the purpose of providing the skips, increased the waste management workload, and left residential areas where these skips were placed unsightly.

"Illegal dumping is becoming an increasingly tough challenge to deal with in the Langeberg municipal area," said Mr Glen Slingers, Manager: Solid Waste. "Not only does it create a health risk to our residents and an eyesore for our visitors, but it also pushes up municipal cleaning costs. Langeberg Municipality is doing its best to discourage illegal dumping, but need our community to join us in this fight."

By following the points below you will become part of recycling in the Langeberg area and ensure that your neighbourhood stays neat and tidy:

- Place your household waste in wheelie bins/black bags and put it outside on scheduled collection days.

- Use your garden waste for composting.
- Drop off garden waste at the Transfer Station in your town.

Communities are encouraged to work with the Langeberg Municipality to ensure that incidents are reported. We urge residents to take down the details of perpetrators and their vehicles, including registration numbers and, if possible, gather photographic evidence, so we can prosecute those who dump illegally.

Langeberg Municipality's Law Enforcement Unit handles the legal aspects of fines and all criminal procedures related to illegal dumping. The minimum fine for dumping or littering is R1 000, but it can be as high as R2 500.

# Misbruikte rommelhouers verwijder

Die rommelhouers wat in die Langeberg-munisipaliteit in woongebiede geplaas is om 'n sentrale punt te skep vir die versameling van tuinafval, is verwyder omdat die houers misbruik word.

Inwoners het oortree deur die rommelhouers vir huishoudelike en ander afval te gebruik eerder as vir tuinafval soos die bedoeling was en dit onwettig daarin gestort. Dit het die oorspronklike doel van die houers misken, die afvalbestuurswerklading verhoog en die woongebiede waar hierdie houers geplaas is, onooglik gemaak.

"Onwettige storting is 'n moeilike uitdaging in die Langeberg-munisipale gebied. Dit hou nie net 'n gesondheidsgevaar vir ons inwoners in nie, maar dit skep 'n vieslike gebied waarin besoekers moet vaskyk nie en verhoog ook munisipale opruimingskoste."

"Die Langeberg-munisipaliteit doen sy bes om onwettige storting te ontmoedig, maar ons het die gemeenskap nodig om hierdie stryd saam met ons te bestry," het mnr. Glen Slingers, die bestuurder van vaste afval, gesê.

Inwoners kan die onderstaande punte volg om deel te wees van herwinning in die Langeberg-omgewing en sodoende verseker dat jou omgewing altyd skoon en netjies bly:

- Plaas jou huishoudelike afval in wieldromme of swart sakke en plaas dit buite op die geskeduleerde dae wat afval afgehaal word;
- Maak kompos van jou tuinrommel; en
- Laai oorbodige tuinafval by die

Die Langeberg-munisipaliteit se wetstoepassingseenheid hanteer die regssaspekte van boetes en alle misdadige procedures wat met onwettige rommel verband hou. Die minimum boete vir storting of rommelstrooiing is R1 000, maar dit kan tot R2 500 wees.

# Dancers making waves

Dancescape South Africa (DSA) is a non-profit organisation, established in 2016 by Fiona and Mitya Sargeant. DSA facilitates dance classes in Zolani every afternoon of the week, where more than 50 kids, ranging from 4 to 19 years old, are taught, employing full-time and trainee teachers. The project helps to get the kids of Zolani off the streets and away from drugs and violence. It stimulates both mind and body and, above all, gives disadvantaged youth hope.

Due to generous funding from various individuals and other organisations, such as the Langeberg Municipality, DSA has been able to effect many improvements.

"We built a proper sprung floor so our dancers could jump minimising

the risk of developing stress injuries," said DSA CEO Mitya Sargeant.

"We were also able to install a barre so that our dancers could participate in ballet barre work."

Opportunities for further training in Cape Town, at institutions such as the Cape Academy of Performing Arts (Capa), have been provided by DSA. Many of the organisation's alumni are working as professional dancers in South Africa and abroad.

#### Family affair

Siblings Siphe, Mthuthuzeli and Aviwe November all started their dance journey at DSA. Siphe is currently based in Canada, with the Canadian National Ballet, while his elder brother, Mthuthuzeli, is a dancer and choreographer with Ballet Black in London. Aviwe

November is the youngest of the three, and is a qualified professional dancer working both locally and abroad.

#### Student life

Lihle Mfene and Lutho Zwenda are currently studying at the Cape Academy of Performing Arts to become professional dancers. Entry to this three-year course is via audition, and both South African and international students of a proficient standard are welcome to apply.

Dancescape South Africa financially supports these students with expenses.

Thimna Ndwe, who is one of DSA's trainee teachers, attended the San Francisco Dance Summer School in 2018. She also taught at the Guguletu Arts and Leadership Project in

preparation for a performance at the Baxter Theatre. Sargeant thanks the municipality for its support: "We rely on the funding of many individuals and organisations from around the world. We thank the Langeberg Municipality for its contribution to helping our organisation, and hope it will continue to support Dancescape South Africa in the future."

Dancescape South Africa (DSA) is 'n organisasie sonder winsbejag wat in 2016 deur Fiona en Mitya Sargeant op die been gebring is.
