

ANALOGUE TV WILL BE SWITCHED OFF ON 31 MARCH 2022

On 31 March 2022, existing analogue television signals will be switched to digital signals. Viewers will then require a decoder to watch channels such as SABC and E-TV. Those who already have satellite dishes and decoders do not need to make any changes. Anyone who has access to electricity, owns a TV and earns less than R3 500 per month, may apply for a free decoder installation package.

What is digital migration?

It is the process of moving from analogue to digital broadcasting. It is often also called digital switchover. Digital migration or switchover is a technology change from the old analogue system to a modern digital system. It is done to deliver a higher-quality viewing experience.

What do I need to migrate to digital television?

You need a digital decoder. It is also known as a Set Top Box (STB), or in short just a decoder. The device decodes digital signals and enables content to be displayed on your television set. Digital signals are transmitted in different ways:

- Digital Terrestrial Television (DTT) uses transmitters on the land, for which you need a TV aerial antenna and a decoder.
- Satellite Direct to Home (DTH) uses a satellite in space, for which you need a satellite dish and a decoder.

If I already use DStv, OpenView or StarSat, do I still need another decoder?

No, unless you want to view the additional channels offered on the DTT. DSTV, OpenView and StarSat already broadcast digital signals via satellite.

Is it neccesary to buy a new television set to receive DTT signals?

No. All old, analogue TV sets can receive DTT signals, provided it is connected to a decoder.

What is integrated digital television?

It is now possible to buy a TV set with a built-in decoder. This is called an integrated digital television (IDTV). An outdoor UHF aerial still needs to pick up the terrestrial signal before the IDTV can decode and display a picture. These television sets carry the "Go Digital" mark. Please note that a "digital ready" or "HD ready" TV cannot receive digital signals without a decoder. Look for the "Go Digital" mark, or the "DVB-T2" mark to confirm that a TV is indeed an IDTV.

What equipment is needed for DTT?

You need a working television set and a decoder (like DSTV or OVHD). As an alternative, you can also get an IDTV, if you live in an area that has digital terrestrial network coverage.

Will I need to pay a monthly subscription fee, as for DStv?

No, if you use a DTT decoder, or a DTH free-to-air decoder, it is free. OpenView is free to air, and you only pay once-off for your decoder and installation.

If, however, you prefer the commercial decoders of DSTV and StarSat, you will have to pay the subscription fee that they charge as your preferred service provider. As required by the law, everyone must also continue to pay the annual TV licence fee for every TV set they own.

Who qualifies for a subsidised decoder?

The government will provide free decoders to five (5) million poor, TV-owning households. The requirements to qualify for the subsidy are:

- You must be a South African citizen, with a South African Identity Document (ID)
- Poor, TV-owning households earning R3500 or less, or receiving a social grant
- Households must own a functioning TV set
- Households already covered by the SABC concessionary TV licence scheme.
- South Africans living in border regions, or in the area that surrounds the SKA in the Northern Cape.

Households with an income more than R3500 per month

Households with earnings more than R3500 per month must purchase their own decoders. DSTV, OpenView and StarSat all decode digital signals. Government decoders are not available on the market yet.

Digital televisions bearing the "Go Digital" mark are however available and suitable to broadcast DTT channels without the need for an additional decoder.

If I have three TV sets in my house, will I need three decoders?

Yes, every TV set needs a separate decoder.



Il through the year Western Cape Health and partners help parents to boost the health of their children. Now, the Department asks that parents and caregivers take swift action to protect young children if they get diarrhoea.

If your child has diarrhoea (a runny tummy) or vomits, you must quickly help them to drink fluids.

If the child does not get better or if you notice danger signs, you must take the child to the hospital immediately.

How can you help?

- Prevent diarrhoea by making sure you and your children wash hands regularly. Keep surfaces in the kitchen clean by using warm water and soap.
- If your child has a runny tummy or vomits, you must help your child to avoid

dehydration. Do as follows: Boil a litre of water and let it cool down. Mix it with eight teaspoons of sugar and half a teaspoon of salt. Give your child small sips of the solution.

- If the child vomits the solution, wait five minutes, and give more small sips of the solution.
- Act on warning signs! Get medical help immediately if there is blood in the child's stool/diaper, if the child has quick, shallow breathing, if the child does not feed or vomits everything, or if your child stares into the distance and is not as alert as usual.

"Because children's bodies are small, having a runny tummy or vomiting can have a major impact on them. You have to quickly help them rehydrate by giving them the sugar salt solution," says Sr Roenell Balie who is part of the team coordinating child health for Western Cape Health in the Cape Winelands.

With the help of nongovernmental organisations Western Cape Health raises awareness about diarrhoeal disease

Bottles and sachets with the dry ingredients that you should mix with water and drink to avoid dehydration, are also distributed in communities. "Remember, you can make this at home.

Do not only rely on the sachets that are distributed," says Balie. "Young children who are up to date with routine immunisation, and who get assistance with nutrition and other services from our clinics can more easily ward of diseases like diarrhoeal disease. Please make use of our services."






The pie chart on the left indicates the directorate's progress and the bar chart on the right indicates the progress per department within that directorate.

VACCINATION REMAINS OUR BEST DEFENCE AGAINST COVID-19

The Western Cape has officially exited the fourth wave of COVID-19. However, it remains important to get as much protection as possible during this period.

Vaccination - Vaccines remain our best defence against COVID-19. It is available to all persons 12 years and older.

Booster Shots - A booster dose increases your immune system and prevents severe illness. It is advisable to get yours. Do not wait to get a telephonic reminder, be proactive. Visit a vaccination site if you had the J&J vaccine two (or more) months ago, or the second Pfizer dose at least six months ago.

Immuno-compromised individuals who already had an additional vaccine dose may take the following booster doses:

- J&J booster dose 2 months after having received the additional vaccine dose or
- Pfizer booster dose 6 months after having received the additional vaccine dose.
