## ■ Documentation required – critical

- Bar coded identity document /smart ID card or proof that person applied for ID
- Thirteen digit ID number for child/ren (birth certificate)
- Proof of assets and income
- Latest three months bank statement
- Medical certificate – disability and care dependency
- Marriage certificate (if married)
- Death certificate (deceased spouse)
- Court order / extension order (foster child)
- Any other document (s) which may affect outcome of application
- Proof of child (between 7 & 18) attending school – child support grant.
- Proof where primary care giver is not biological parent (affidavit from parent(s) or SAPS, or social worker report or report from principal) – child support grant.

Registration of birth ( below 30 days)	FREE	Mother or father if parents are married/ appointed legal guardian/ Social worker (with background report. Original ID of person registering the child. Late Registration of Birth ( 31 days to 14 years)	FREE	Mother or father if parents are married/ appointed legal guardian/ Social worker (with background report. Original ID of person registering the child's Parent(s) details & marriage certificate if applicable. Proof of birth ie. Maternity letter / clinic card / baptismal cert.( issued within 5years of birth) / Social worker report.
Late Registration of birth( 15 years and above)	FREE	Applicant Informant and Identity Document preferably the parents. 2x ID photographs (of the applicant) Parent(s) details (i.e. ID numbers)& marriage cert. if applicable. Proof of birth ie. Maternity letter / clinic card / baptismal cert.( issued within 5years of birth) / School extract from Primary School.
