NOMINASIES VIR KANDIDATE OM IN DIE WES-KAAPSE TAALKOMITEE TE DIEN

Die Wes-Kaapse Provinsiale Parlement se Staande Komitee oor Kultuursake en Sport, ter voldoening aan artikel 7 van die Wes-Kaapse Provinsiale Talewet, 1998 (Wet 13 van 1998), nooi die algemene publiek uit om geskikte persone as lede van die Wes-Kaapse Taalkomitee te nomineer. Die aangestelde genomineerdes sal 'n ampstermyn van drie jaar dien. Die Wes-Kaapse Taalkomitee monitor taalbeleid en ander taalaangeleenthede in die Wes-Kaap en tree in 'n raadgevende hoedanigheid op vir die Wes-Kaapse Regering, die Wes-Kaapse Provinsiale Parlement en die Pan-Suid-Afrikaanse Taalraad.

Die mandaat van die Wes-Kaapse Taalkomitee word voorgeskryf in die bepalings van die Wet op die Pan-Suid-Afrikaanse Taalraad, 1995 (Wet 59 van 1995), die Grondwet van die Wes-Kaap, 1998 (Wet 1 van 1998), en die Wes-Kaapse Provinsiale Talewet, 1998 (Wet 13 van 1998).

Die lede van die Wes-Kaapse Taalkomitee verteenwoordig al die sprekers van die drie amptelike tale van die Wes-Kaap, naamlik Afrikaans, Engels en Xhosa, asook Suid-Afrikaanse Gebaretaal en voorheen gemarginaliseerde inheemse tale van die Wes-Kaap.

Vereistes: Genomineerdes moet: • Suid-Afrikaanse burgers • Ten minste 21 jaar oud wees • Permanente burgers van die Wes-Kaap wees. Kandidate moet: • Vlot wees in ten minste twee van die drie amptelike tale van die Wes-Kaap • 'n Aktiewe belangstelling in en kennis van taalaangeleenthede hê. Suksesvolle kandidate moet in staat wees om jaarliks ten minste vier voltallige vergaderings van die Wes-Kaapse Taalkomitee en verskeie subkomiteevergaderings by te woon.

Nominasies moet op die voorgeskrewe nominasievorm gemaak word en ingedien word nie later nie as 14 September 2018 om 12:00.

NOMINATIONS FOR CANDIDATES TO SERVE ON THE WESTERN CAPE LANGUAGE COMMITTEE

The Western Cape Provincial Parliament's Standing Committee on Cultural Affairs and Sport, in compliance with section 7 of the Western Cape Provincial Languages Act (Act 13 of 1998), invites the general public to nominate suitable persons as members of the Western Cape Language Committee. Appointed nominees will serve a three-year term of office. The Language Committee monitors language policy and other language matters in the Western Cape and acts in an advisory capacity to the Provincial Government of the Western Cape, the Provincial Parliament and the Pan South African Language Board (PanSALB).

The mandate of the Western Cape Language Committee is prescribed in the provisions of the Pan South African Language Board Act (Act 59 of 1995), the Constitution of the Western Cape (Act 1 of 1998), and the Western Cape Provincial Languages Act (Act 13 of 1998).

The members of the Western Cape Language Committee represent the users of the three official languages of the Western Cape, namely Afrikaans, English and isiXhosa, South African Sign Language, as well as the previously marginalised indigenous languages of the Western Cape.

Requirements: Nominees must be: • South African citizens • At least 21 years of age • Permanent residents of the Western Cape. Candidates must have: • Full command of at least two of the three official languages of the Western Cape • An active interest in or knowledge of language matters. Successful candidates must be able to attend at least four plenary meetings of the Language Committee and several subcommittee meetings per year.

Nominations must be made on the prescribed nomination form and submitted by no later than 12:00 on 14 September 2018.
