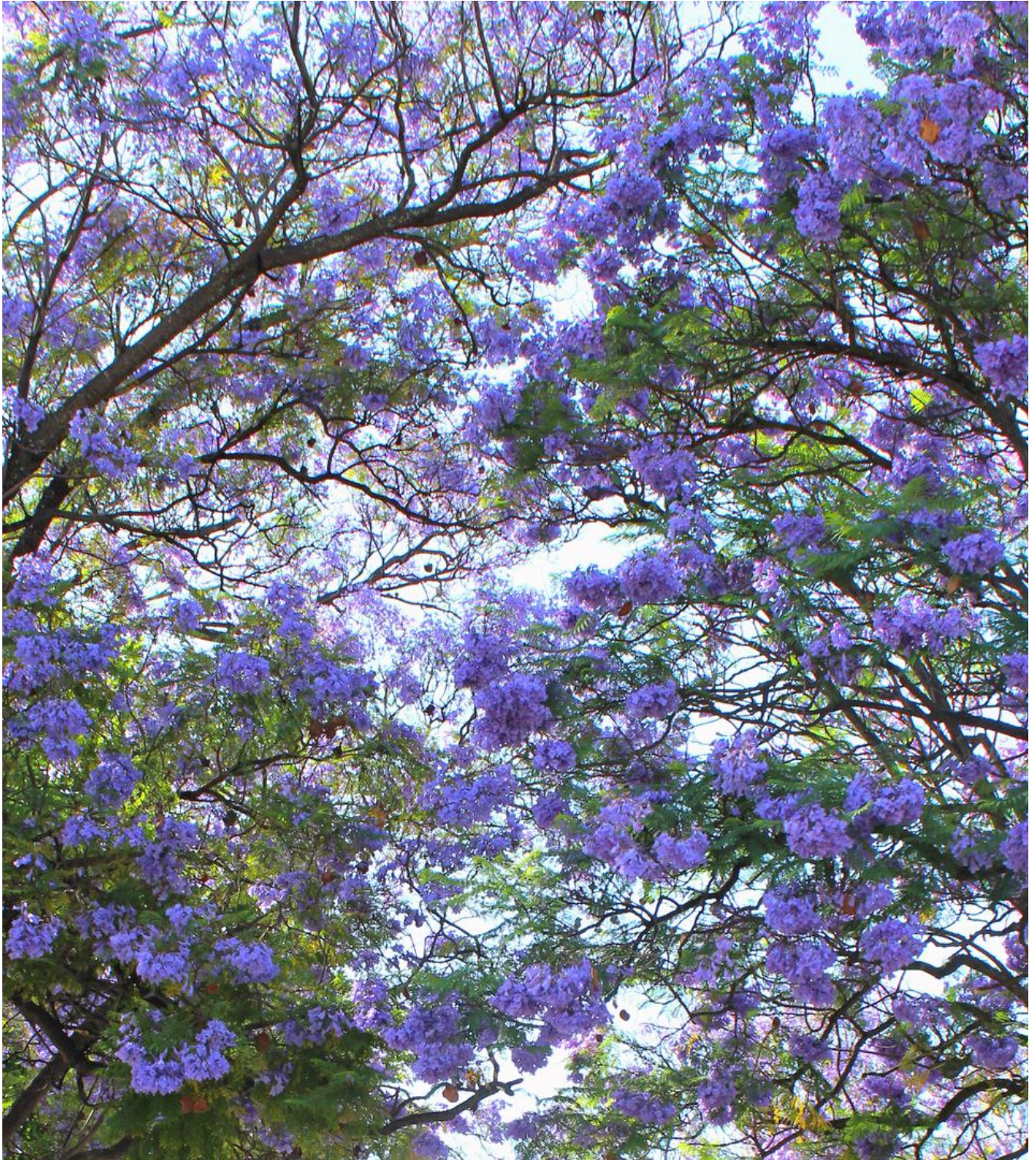

# 16 DAYS ACTIVISM



The 16 Days of Activism for No Violence against Women and Children Campaign is a United Nations campaign which takes place annually from 25 November (International Day of No Violence against Women) to 10 December (International Human Rights Day).

Given the scourge of Gender-Based violence in the country, which is declared a national address, government is implementing the Emergency Response Action Plan on Gender-Based Violence and Femicide, which was announced by President Cyril in September 2019.

The 16 Days Campaign forms the centre point of government's comprehensive 365 Days of Activism for No Violence Against Women and Children.

During the 16 Days period, Government together with civil society and the private sector will host a series of community and sector dialogues and activities to foster a collaborative effort in dealing with GBVF.

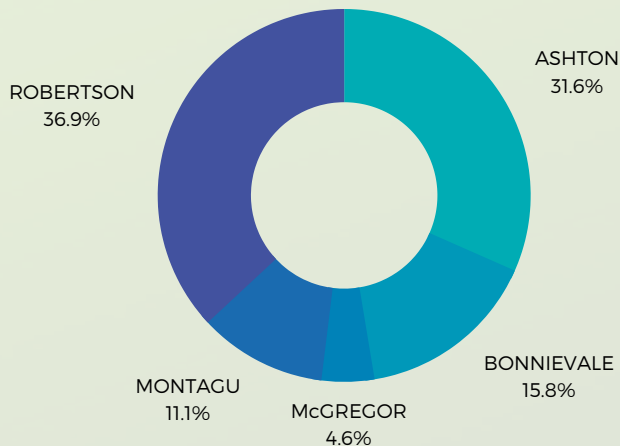

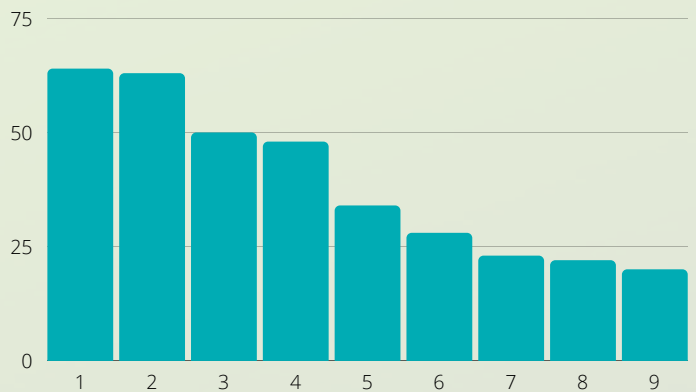

# LANGEBERG MUNICIPALITY'S PLAN FOR LONG-TERM ENERGY SUSTAINABILITY

Langeberg Municipality will aim to procure alternative energy from Independent Power Producers by 2026.

Following a council decision, Langeberg municipality has now commenced with a public participation process to allow the public to comment on the ENERGY OUTLOOK AND ALTERNATIVE GENERATION IN LANGEBERG.

## Our current and future supply from ESKOM

With Eskom unable to meet its demand, municipalities need to secure self-generation and alternative energy sources to supplement the energy deficit.

The Municipality is in the process of procuring the last available capacity on Eskom network that supplies Langeberg (3MVA) at a cost of approx. R17 million. The Eskom corridor that supplies electricity to Langeberg is constrained and any future capacity will require the Bacchus-Klipdrif 132kV line to be upgraded. Eskom plans this project in the 5 to 10-year horizon and it could cost in excess of R200 million.

We still rely on Eskom to supply the approx. 75MVA of electricity required to power Langeberg Municipality in peak demand season (around February and March.)

## Electrical Master Plan to address the supply and demand shortage

Langeberg Municipality have updated its Electrical Master Plan per town in June 2022. Our electrical

load profile indicates a continuous growth in all towns of Langeberg Municipality with potential new developments requiring approximately 21.5MVA.

The demand for electrical capacity will exceed the supply from 2024/2025 which will slow development and growth; all the more reason to procure energy from alternative sources. The Robertson network demand is already exceeding the supply.

The Master Plan proposes major capital projects required to keep the electrical network operational and to increase network capacity (as per the available budget).

## Our Alternative Generation Options

The likely scenario for procuring alternative energy will be Municipal IPP procurement program where Independent Power Producers's will bid for projects that are located on a non-municipal site and the municipality does not take any site or development risks (as per Scenario 2 outlined in the Council Resolution A4410 available on [www.langeberg.gov.za](http://www.langeberg.gov.za))

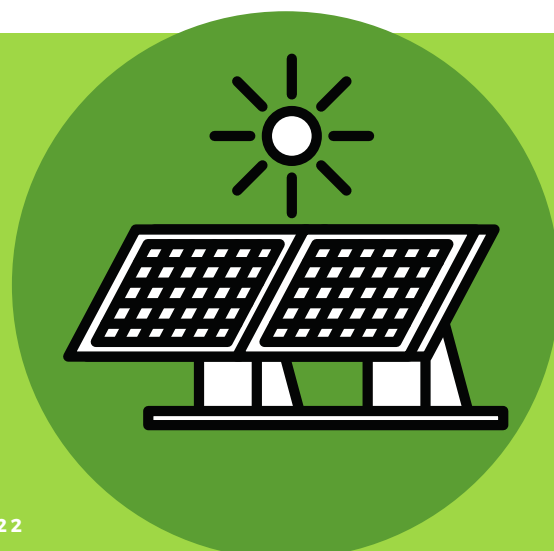
Some of the technologies to consider are: Solar PV generation, Concentrated Solar, Wind, Battery Energy Storage System (BESS), Hydro, Gas / Diesel generation, Hydrogen generation and Biomass / Biogas generation

The technical considerations that adds to the complexity of alternative energy are the feed-in points, base generation demand & capacity, possible peak shaving, load shedding and energy efficiency.

# WHEELING ELECTRICITY BY 2024

## Wheeling electricity is a good alternative

The method of 'wheeling electricity' on municipality grid is where private operators at one location can supply electricity to a buyer or off-taker in another location via the municipal network. By wheeling electricity through the municipal grid to businesses and individuals, it:

- encourages and attracts renewable energy investment,
- creates competition in the energy market that could drive down prices and give customers more choice
- and establishes a business-friendly environment for local businesses and residents,
- creates another revenue stream for the municipality.

Wheeling and electricity trading will be a key part of South Africa's energy mix in the future.

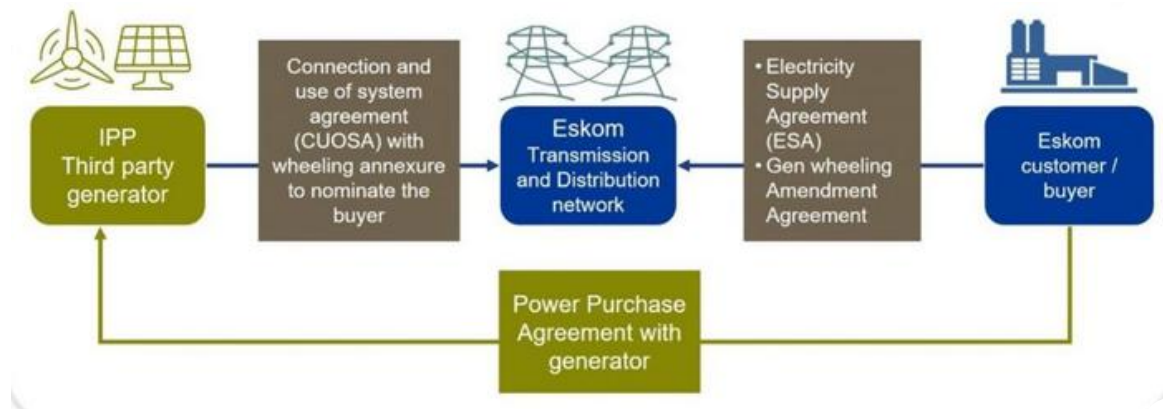
Electricity wheeling in Langeberg Municipal area could be introduced as soon as 2024.

## How will this impact electrical supply tariffs?

With the new energy mix, the tariffs structures will have to be revised. This means that any cost benefit from the procurement of alternative energy could be passed on to the consumer.

The National Energy Regulator of South Africa (NERSA) requires a cost of supply study to be done before Municipal tariffs can be adjusted. It is recommended that budget be made available to appoint an expert consultant to conduct the cost of supply study and calculate revised tariffs.

## GENERATOR AT YOU HOME?

In terms of generating alternative electricity at your private, commercial, industrial or agricultural property, council approved **Guidelines for Small Scale Embedded Generation** in Feb 2018.

As the Alternative Energy (AE) industry & technology evolved Langeberg Municipality has made great strides for all municipal customers wishing to install alternative electrical generation. Council approved

**World AIDS Day is commemorated each year on the 1st of December** and is an opportunity for every community to unite in the fight against HIV, show support for people living with HIV and remember those who have died.

### **HIV and AIDS in South Africa**

South Africa has been relentless in its mission to turn the HIV, AIDS, and TB epidemics around and there are notable achievements to celebrate. A review of our efforts in addressing the HIV and AIDS epidemic over the past 20 years, paints a mixed picture.

There have been many scientific advances in HIV treatment and we now have a much better understanding of the virus. More people are receiving antiretroviral treatment, which means HIV infection rates are decreasing. There is also a scientific optimism around the benefits of treatment as prevention, and progress towards a cure and vaccine.

However, despite these advances, stigma and discrimination still persist for many people living with, or affected by HIV. World AIDS Day 2022 is an opportunity for all South Africans to remind themselves that HIV is still a reality and that it is incumbent on all of us to continue fighting prejudice, stigma and discrimination.

### **South Africa has come a long way in the fight against HIV and AIDS.**

Despite our many advances we still struggle to eliminate the stigma associated with HIV infection and the resultant discrimination. There are still people with limited knowledge of the facts about how to protect themselves and others.

The devastating effects include abandonment by spouse or family, social ostracism, job and property loss, school expulsion, denial of medical services, lack of care and support, and violence.

It also results in a lower uptake of HIV preventive services and postponing or rejecting care. Women tend to experience greater stigma and discrimination

than men and are more likely to experience its harshest and most damaging effects.

World AIDS Day is important as it reminds the public that HIV has not gone away and that collectively, there is the need to increase awareness, fight prejudice and improve education to maintain and achieve the aims and objectives of the country as set out in the National Strategic Plan on HIV, STIs and TB 2012-2016.

### **Why stigma and discrimination matter**

Stigma and discrimination can be as devastating as the illness itself and may mean abandonment by a partner or family, social exclusion, job and property loss, school expulsion, denial of medical services, lack of care and support, and violence for those affected by them. These consequences, or fear of them, mean that people are less likely to come in for HIV testing, disclose their HIV status to others, adopt HIV preventive behaviour or access treatment, care and support.

Every sexually active South African is at risk of contracting HIV. **We call on all South Africans to recognise that HIV and AIDS are chronic diseases, and that people living with HIV can have full and happy lives.** We each have a responsibility to treat those who are struggling with an HIV-positive diagnosis with compassion, those struggling with AIDS with care, and ourselves and our sexual partners with respect. Addressing stigma and discrimination is important in mitigating the impact of HIV.

### **Get Tested**

The only way to know your HIV status is to get tested. Knowing your status gives you powerful information to keep you and your partner healthy. It's relatively easy to get tested for HIV in South Africa. You can do so at your doctor, local clinic or any public health facility.
