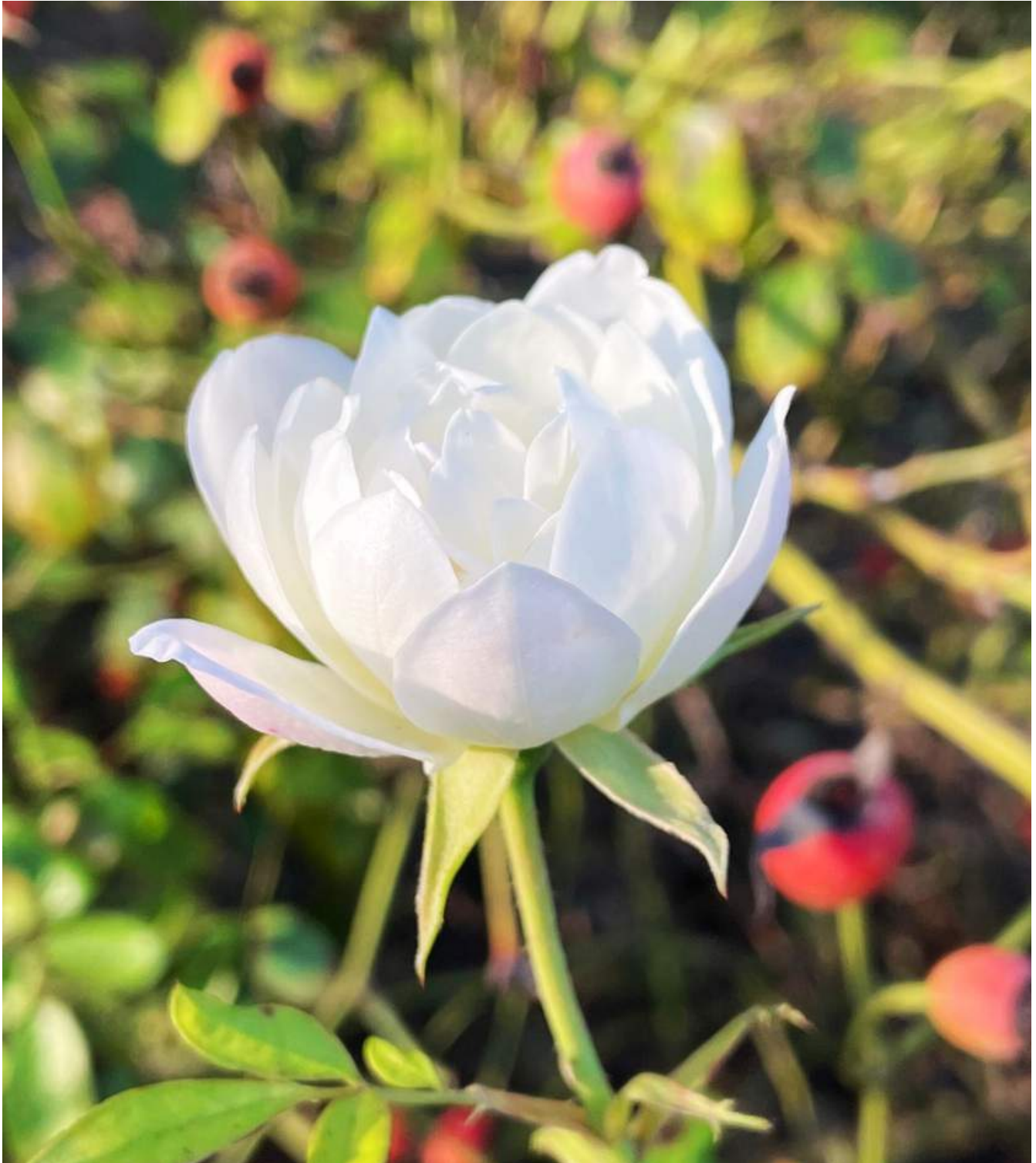

HERITAGE DAG MESSAGE FROM THE EXECUTIVE MAYOR

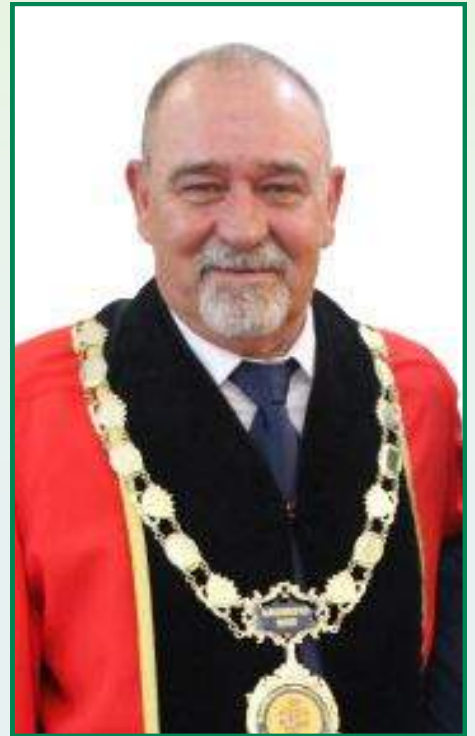

NEW OPERATING HOURS FOR LANGEBERG MUNICIPALITY

As of Monday, 04 September 2023 Langeberg Municipality's operating hours has changed.

Langeberg Municipal senior management, with the approval of Council, initiated a process to make changes to the municipal operational hours for staff to start work 15 minutes earlier at 07:45 on weekdays in order to close offices at 15:15 on Friday afternoons. The process entailed engagements with the labour representative unions as well as non-union members, for a favourable outcome.

The new operating hours will be as follows:

Office Hours

Mondays–Thursdays: 07:45–16:30

Fridays, 07:45–15:15

Municipal Cashier Points Hours

Monday–Thursday: 07:45–16:30

Friday: 07:45–14:45

Traffic Cashier Points Hours

Monday–Thursday: 07:45–16:30

Friday: 07:45–14:00

Library hours will remain the same, with the exception of Fridays, when the libraries close at 15:15.

In compliance with the Basic Conditions of Employment Act, lunch will start at 12:45 and end at 13:15 on Mondays to Fridays.



A SECOND ENTRANCE FOR NKQUBELA



Nkqubela currently has only one entrance available from Voortrekker Street, Robertson. Due to the high volume of traffic that use this intersection, it's become necessary to add a second entrance to Nkqubela on R317. This is expected to ease traffic volumes at the current intersection. The project, which also includes the addition of a traffic circle, will make it safer and more convenient to get to and from Nkqubela, improving traffic flow.

The design of this new circular intersection is very similar to the one already in Voortrekker Street. The size of the circle has been carefully designed to accommodate heavy vehicles and for peak traffic flow with minimal delay. To enhance safety, the circle will be lit up at night to help drivers navigate around it.

The cost of the project is R 9 016 589.91 and is funded by National Treasury's Neighbourhood Development Partnership Grant (NDPG).

The primary focus of the NDPG is to stimulate and accelerate investment in poor, underserved residential neighbourhoods by providing technical assistance and capital grant financing for municipal projects that have either a distinct private sector element or an intention to achieve this.

The construction of the circle is set to be finished by the end of October 2023. As there are currently construction on the R317, we ask all drivers to adhere to the speed limits and drive cautiously.

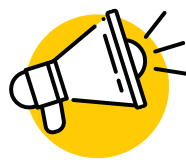
He has had vast exposure to digitalization initiatives, people management, change management, incident management, problem management, and ICT project management.

DO YOU QUALIFY FOR INDIGENT SUBSIDY?

The Langeberg Municipality, in their ongoing effort to aid poverty alleviation in the municipal area, currently supports a total of 6 043 households who are deemed as indigent. These indigent households are residential consumers with a monthly household income of less than R 4 190. Residential properties valued up to R80 000, are also exempted from paying rates.

Section 27 of the South African Constitution states that: "Everyone has the right to have access to social security, including, if they are unable to support themselves and their dependents, appropriate social assistance. The state must take reasonable legislative and other measures, within its available resources, to achieve the progressive realization of each of these rights"; and the indigent subsidy is merely one way the Langeberg Municipality adheres to the act.



Beneficiaries of the subsidy receive the following for free:

- their first six kiloliters of water
- their first 50 kilowatt-hours of electricity
- subsidy equally to the charges for waste collection and sewerage per month

The indigent grant will be withdrawn from any person who:

- Runs a spaza shop illegally from the premises receiving subsidy
- Allows illegal electricity connections to the premises receiving an indigent grant
- Subleases the premises receiving an indigent grant, which means that the applicant is not personally occupying the premises

Here is some important information to note if you want to apply for an indigent subsidy.

Documentation needed:

- Copy of ID and birth certificates of everyone staying on the property
- Proof of income of everyone staying on the property, i.e. pay slips, bank statements or an affidavit for unemployment or self employed
- Latest municipal account

Qualification criteria

- Applicable to households on residential property
- Own only one property
- Only the account holder may apply
- Full-time occupant of the residential property or where the registered owner is unable to occupy the property
- Joint household income must not exceed R4190.00 per month

Misrepresentation

Any person who has received any benefit or relief in terms of this policy and who has misrepresented themselves in order to qualify for

such benefit or relief will be deemed to have committed an offence.

Remedial measures will thus be taken in a manner as determined by the Council from time to time.

The Municipal Manager will reverse all benefits and relief received; and raise any fee, as determined by Council from time to time, as set out in the Tariff Policy.

The Municipal Manager shall report any misrepresentation in terms of this policy to the South African Police Services.

HPV VACCINATIONS IN SCHOOLS: HELP US TO PROTECT YOUNG GIRLS

Between 4 September and 31 October 2023, the Western Cape Department of Health and Wellness will administer the second round of the human papillomavirus (HPV) vaccine which prevents cervical cancer.

Girls in Grade 5, over the age of 9, who have received the vaccine earlier this year will be able to have their booster doses after the appropriate parental consent has been obtained.

During the first-round of HPV vaccination, a total of 1,044 schools were visited and 76% of the children received their 1st dose, which allows us the opportunity to provide the same number of vaccinations over the second round.

Cervical cancer is the leading cause of cancer deaths amongst women aged 15 to 44 years in South Africa with about 70% of invasive cancers caused by the HPV serotypes 16 and 18. As such, the department remains committed in eliminating cervical cancer as effectively as we can through nurses and colleagues who are equally as important in facilitating the intervention through their contributions.

To obtain maximum effectiveness the vaccine needs to be administered before any sexual

activity or intimate contact occurs, which means vaccinating as early as aged 9.

“Ensuring the second dose of HPV vaccination gives your daughter the appropriate defense in prevention of cervical cancer later on in life and give you peace of mind in knowing your daughter is protected,” says Sonia Botha, Deputy Director in Child’s Health.

The HPV vaccination campaign is dependent on the support of parents and caregivers and as such, it is necessary that the consent forms completed and submitted to the schools prior to the nurses’ visits.

“We enjoy bringing this opportunity to young girls. By bringing it to the school, parents don’t have to take time off work to take their child to the clinic for this life-saving vaccine,” says Sr Roenell Balie of the Western Cape Department of Health and Wellness in the Cape Winelands. “But we do need your help, mom/dad. Please sign the consent form and submit it to the school.”

The HPV campaign brings hope to us all for a world free from cervical cancer, and HPV infection can be reduced if herd immunity is achieved using the vaccine.

HOW TO APPLY FOR A BUSINESS LICENSE



If you are operating any of the following businesses in the Langeberg municipal area, you must be in possession of a Business License, in terms of the Business Act, 1991 (Act 71 of 1991). The following formal and informal business needs to apply:

Formal Businesses

- Any business providing meals for on, or off the premises consumption (for example: hot dogs, hamburgers, sandwiches, wraps, breakfast and sit-down meals)
- Any business trading in perishable foodstuffs (for example: milk, meat, fish and fish products)
- Any facility providing Turkish baths, saunas, and health baths
- Any facility providing massages, or infra-red treatment
- Any business making the provision of escort services of males and/or females available
- Any business keeping 3, or more mechanical, electronic, or electrical devices for recreation or amusement (for example: slot machines, Pin Ball machines)
- Any business keeping of 3, or more snooker or billiard tables
- Any business operating a night club, or discotheque
- Any business operating a cinema, or theatre
- Any business conducting an adult premises in terms of Section 24 of the Films and Publications Act, 1996.

Informal Businesses

Any business selling foodstuffs in the form of meals, or perishable foodstuffs which is conveyed from place to place by vehicle, or from a movable structure (for example: a food truck or trailer, a temporary structure at an event, or a market, or from an approved informal trading area)

The following businesses are exempt from obtaining a business license:

- Business operated by the state or municipality (e.g.: municipal canteen)
- Business operated by a charitable, religious, educational, or cultural institution, agricultural organization, only if all the profits are solely devoted to the purposes of that organization (e.g., school tuck shop, church bazaar)

- The informal traders selling clothing, flowers, haberdashery, fruit and vegetables from an approved informal trading area.
- All other formal and informal businesses not mentioned above.

Before any formal business license can be considered, all businesses must:

- be conducted from an approved structure/building,
- comply with the Langeberg Municipal Zoning Scheme,
- comply with fire and health requirements, and
- in some cases, get SAPS approval.

Food premises will also need to obtain a Certificate of Acceptability from the Cape Winelands District Municipality. This is to ensure that the premises comply with health standards.

NB! Both formal and informal businesses trading with food and perishable foodstuffs MUST be in possession of both a Business License, and a Certificate of Acceptability.

Application Process

Obtain a Business license application form from Ms Thandeka Danti who can be contacted by email: tdanti@langeberg.gov.za, by phone: 023 626 8263, or at the office: Commando Building, 04 Church Street, Robertson.

The application form must be completed, and the applicable levy paid. The completed application and proof of payment must be submitted to Ms T Danti.

The application will be circulated for comments and if the premises are compliant, your Business License will be issued within 21 working days.

If there are any outstanding matters, the business license will only be issued once all issues have been addressed.

HOW TO APPLY FOR EVENTS

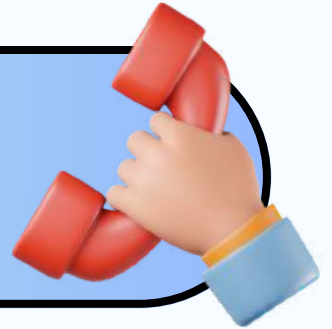

Event applications need to be submitted at least two month before the actual event date. The following steps will guide you through how the process works.

If it determined that your event needs to follow the application process, an application form will be made available to complete. Once complete application, relevant document and proof of payment is received, and checked for completeness in terms of the Event Requirements document ([Click here for the application form](#)).

Evaluation of application

The complete application is sent to all Event Evaluation Team members to provide inputs. Clarity on comments / concerns are taken up with the event organizer. The comments are then included in a letter detailing the application outcome which is submitted to the Municipal Manager for review and signature.

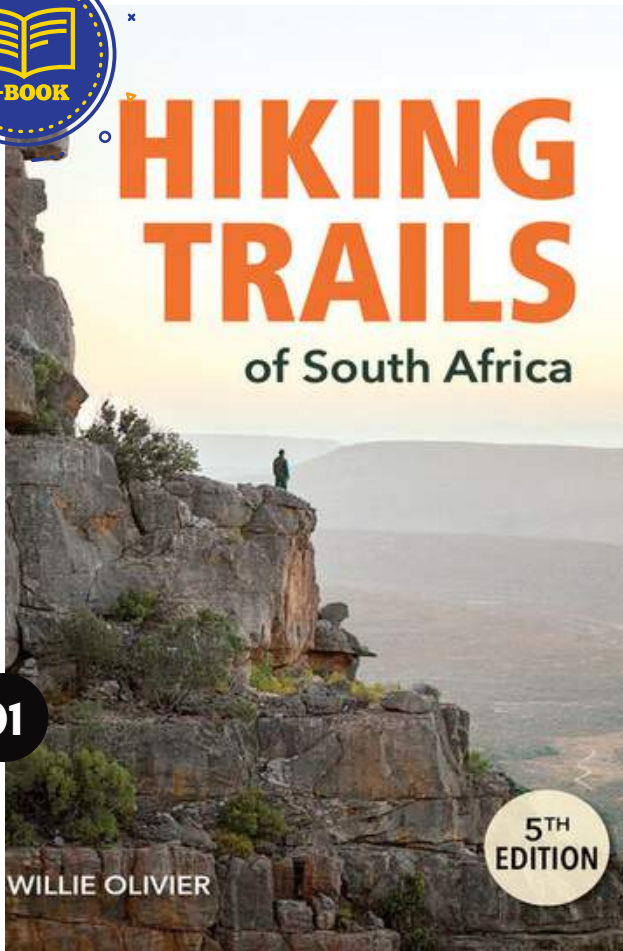
