**MEET THE NEW  
MUNICIPAL MANAGER**

**MR DANIËL LUBBE**

Meet our Municipal Manager, Mr Daniël Lubbe, a seasoned professional with 32 years of experience in local government who started at Langeberg Municipality on 1 March 2023. His journey began in 1990 when he joined a regional services council in the old Transvaal.

Reflecting on his early career, Lubbe recalls, "I grew up in Pretoria and lived there for the first 27 years of my life. When I first started working in local government, I never imagined the journey it would take me on."

In 1992, Lubbe moved to KwaZulu-Natal, where he worked on municipal changes that were at the forefront of a national effort to create "wall-to-wall municipalities." He explains, "There is not a piece of land in South Africa that does not fall under a municipality. Everyone worked towards it. And I had the privilege of being right in the forefront of this process."

Lubbe's experience in KwaZulu-Natal was a highlight of his career. "I learned all the time, it was about what everyone planned for the country," he says. "I worked with 330 council members, of which 66 were Amakhosi Zulu leaders. It was good times and good collaboration, and it really prepared me for my profession going forward."

Over the years, Lubbe progressed through the ranks, from chief administrative officer to assistant director, deputy director, director, deputy municipal manager and municipal manager. He admits that "nothing came easy," but he applied for every opportunity that came his way and was fortunate enough to land the job.

At the end of 2013, after working for some 22 years, for the district municipality in Richards Bay, he worked as a consultant at the South African Local Government Association (SALGA). He had the privilege of writing the National exams of SALGA, for all who wanted to serve

on SALGA's panel of consultants on local government. They then appointed him as National Lead Consultant on a number of local government assignments and he also trained municipal council members. He did it for three years and really enjoyed working in municipalities from big to small.

After that, Lubbe moved from KwaZulu-Natal to the Western Cape where he was with Matzikama Municipality as a Municipal Manager for about three years from 2017. Whereafter, he went to Theewaterskloof Municipality for a short contract as Municipal Manager until after the local government elections of November 2021.

Mr. Lubbe's achievements include serving as Principal Officer to the European Union, overseeing the implementation of Economic Development Projects across municipal boundaries of the district and participating local municipalities. He was also appointed as the FIFA 2010 Soccer World Cup Strategic Readiness Manager, responsible for ensuring that the King Cetshwayo District Municipality (previously uThungulu District Municipality) acted as an official satellite to the Ethekwini Metro Municipality for hosting the 2010 event. "After the 2010 event, I successfully negotiated an anchor tenant for the stadium, the Thanda Royal Zulu, a 1st Division Soccer Team, which now utilized the facilities as its base and hosts championship matches at the stadium," says Mr. Lubbe.

At Uthungulu District Municipality on the Zululand North Coast, Lubbe says he was blessed with the large open areas, the green mountains, and beautiful coastal areas as his surroundings, so Langeberg was an easy choice when he applied for this position.

Everything that Langeberg offers from the beautiful mountains, hiking trails, the unique character of each town, is what attracted him to the area.

Lubbe is committed to making Langeberg one of the top municipalities in the Western Cape. "It will be hard work, but I know it is possible because we have a very good political leadership, a very good management team, and very good colleagues who work here," he says.

To achieve his vision for Langeberg, Lubbe is focused on delivering high-quality services, maintaining, and developing infrastructure, and promoting social and economic development. "We have to concentrate on what the Constitution of our country says and use that as guideline," he explains.

Lubbe's passion for local government is evident in everything he does. He believes that "local government is where the real work happens, where we can make a tangible difference in people's lives. I'm grateful for every opportunity I've had and every challenge I've faced. I'm excited to see what the future holds."

Lubbe has pledged to work for the betterment of the community. He stated, "I'm here in the office and I'm going to give my best for the community. This includes everyone - people in the towns, rural areas, our taxpayers the workers, business owners, etc."

One of Lubbe's top priorities is to spend time in every town in Langeberg to get to know the people and identify their problems.

He stated, "Another thing that is very important to me is to spend time in every town in the Langeberg, something I have already undertaken. That way I can get to know the people, identify problems, listen to complaints so that no town is singled out over another. Every town, every rural area is equally important. There are no favourites. We are going to make the whole of Langeberg successful."

# LANGEBERG MUNICIPALITY APPOINTS SERVICE PROVIDER FOR ELECTRICITY DISCONNECTIONS

Langeberg Municipality has appointed a new service provider to assist with the disconnection and reconnection of electricity supply for defaulting users due to limited internal capacity. The service provider, Spectrum Utility Management (SUM), will be responsible for disconnecting electricity services to users who have not paid their bills in accordance with the Credit Control & Debt Collection Policy of the municipality.

The disconnections will take place from Monday to Thursday, every week in all the five towns of Langeberg Municipality, namely Robertson, Montagu, Ashton, McGregor, and Bonnievale. Reconnections will be done from Monday to Friday of every week. The service provider will operate 24 hours a day, 7 days a week to assist with potential after-hours reconnections of restrictions.

To be reconnected, account holders must pay the amount specified on the notice and any other debt, including the reconnection fee, or make a suitable payment arrangement.

Residents can identify the service provider by the company identification card carried by SUM officials, as well as the municipal letter on the official letterhead authorizing them to perform the disconnection or reconnection

The service provider will take the disconnection meter reading and seal the meter as an indication that the electricity has been disconnected due to non-payment. The service provider will also need access to the electrical kiosk box.

Residents are urged to settle their service accounts to avoid disconnection of electricity supply and any additional costs, including reconnection fees. If residents have any questions or need to confirm the identity of the service provider, they can contact the municipal call centre. The call centre will assist or refer the questions to the relevant municipal official in the debt collection and credit control unit or to the service provider.

The appointment of the new service provider will ensure timely disconnection and reconnection of electricity supply for defaulting users in Langeberg Municipality. It is important for residents to settle their service accounts to avoid disconnection and additional costs. The municipal call centre is available to assist residents with any questions or concerns they may have.

# JOIN US IN THE FIGHT AGAINST ILLEGAL SQUATTING



Over the past few years, informal areas in the Langeberg area have almost doubled and was recently estimated at 2396:

- Ashton Cogmanskloof - 135
- Asnton Zolani - 377
- Mc Gregor - 280
- Montagu Mandela Square - 248
- Robertson Nkanini & Kenana - 766
- Robertson North - 142
- Bonnievale Boekenhoutskloof - 448

This is a great concern to both the municipality and the community. Hence the Langeberg Municipality urge communities to act promptly by immediately reporting the erection of any structure.

## WHAT IS SQUATTING?

Squatting is when someone occupy vacant land or property without the owner's permission.

- In terms of South African law, no person has the right to occupy property without the permission of the owner, unless this is sanctioned by a court order.
- Illegal land invasions undermine the municipal policy on the allocation of land or houses.
- Putting up a structure without an approved building plan is illegal and subject to a fine.

## ILLEGAL LAND INVASION SIGNIFICANTLY IMPACTS ON THE HOUSING BACKLOG

- It delays the delivery of houses, schools, clinics and hospitals.

- It hampers economic growth and job opportunities for the community.
- It poses life threatening risks, such as fire, flood, safety & health issues as the location is often unreachable for basic municipal and emergency services.

## SQUATTING DOES NOT EARN YOU A HOUSING OPPORTUNITY

It is important to know that land invasion/ illegal squatting, does not automatically guarantee you a housing opportunity. The current housing backlog currently stands at 9 469 and grows daily.


Langeberg Municipality makes use of its Housing Allocation and Selection Policy in allocating housing opportunities. Only registered applicants on the housing database will be considered. So, squatting will not guarantee anyone a prioritised allocation ahead of someone on the waiting list.

According to the latest housing allocation regulation priority will be given to the aged (60 and above), disabled and military veterans.

Residents in need of housing can register themselves at the nearest housing office by completing a housing application form.

# OFFICERS ENSURING MUNICIPAL BY-LAWS ARE ENFORCED

Law Enforcement Officers play a crucial role in maintaining order and safety in our communities. In the Langeberg municipal area, there are six Law Enforcement Officers who are responsible for enforcing the Langeberg Municipality's by-laws. These officers work tirelessly to ensure that citizens are abiding to by-laws and regulations put in place to ensure effective service delivery and cooperative communities.

Law Enforcement Officers also work closely with different government organizations, such as the South African Police Service. By collaborating with other organizations, they can effectively address issues related to crime and public safety.

Our by-laws provide procedures, methods and practices to regulate issues around selling liquor, informal trading, municipal land use planning, integrated zoning scheme like operating a business in a residential area, supply of electricity, supply of irrigation water, use of sewerage and sanitation services, utilization of streets, noise complaints, keeping of animals, pound use, control of cemeteries, hosting of events, use of public amenities, and the preservation of the environment like air quality and integrated waste management to mention a few.

The top complaints reported to Law Enforcement Officers is about Illegal Hawkers. These are people who sell goods on the street without a permit, which is against the law.

Law enforcement officers have the power to confiscate goods, issue compliance notices and fines, and shut down illegal operations where by-laws are infringed upon. Their functions and responsibilities are varied, and they must have certain requirements and skills to effectively serve their communities.

Their functions and responsibilities are varied and include maintaining safety and security through the application of laid-down policing, protection, and rescue procedures, attending to processes aimed at ensuring compliance with laws, by-laws, and regulations. Law Enforcement Officers also attend to documentation and notification procedures, serving of summons, compliance orders, executing warrants of arrest, and preparing statements.


They undertake specific activities during disasters and emergency situations, complete specific reports, statutory documentation, and registers, and attend to the application of specific maintenance sequences with respect to equipment and vehicles. It is important for law enforcement officers to keep abreast of the latest legislative changes, developments, and emerging trends in the profession to effectively serve their communities.




