ORGANISATION STRUCTURE: CIVIL ENGINEERING SERVICES – ROBERTSON & MCGREGOR

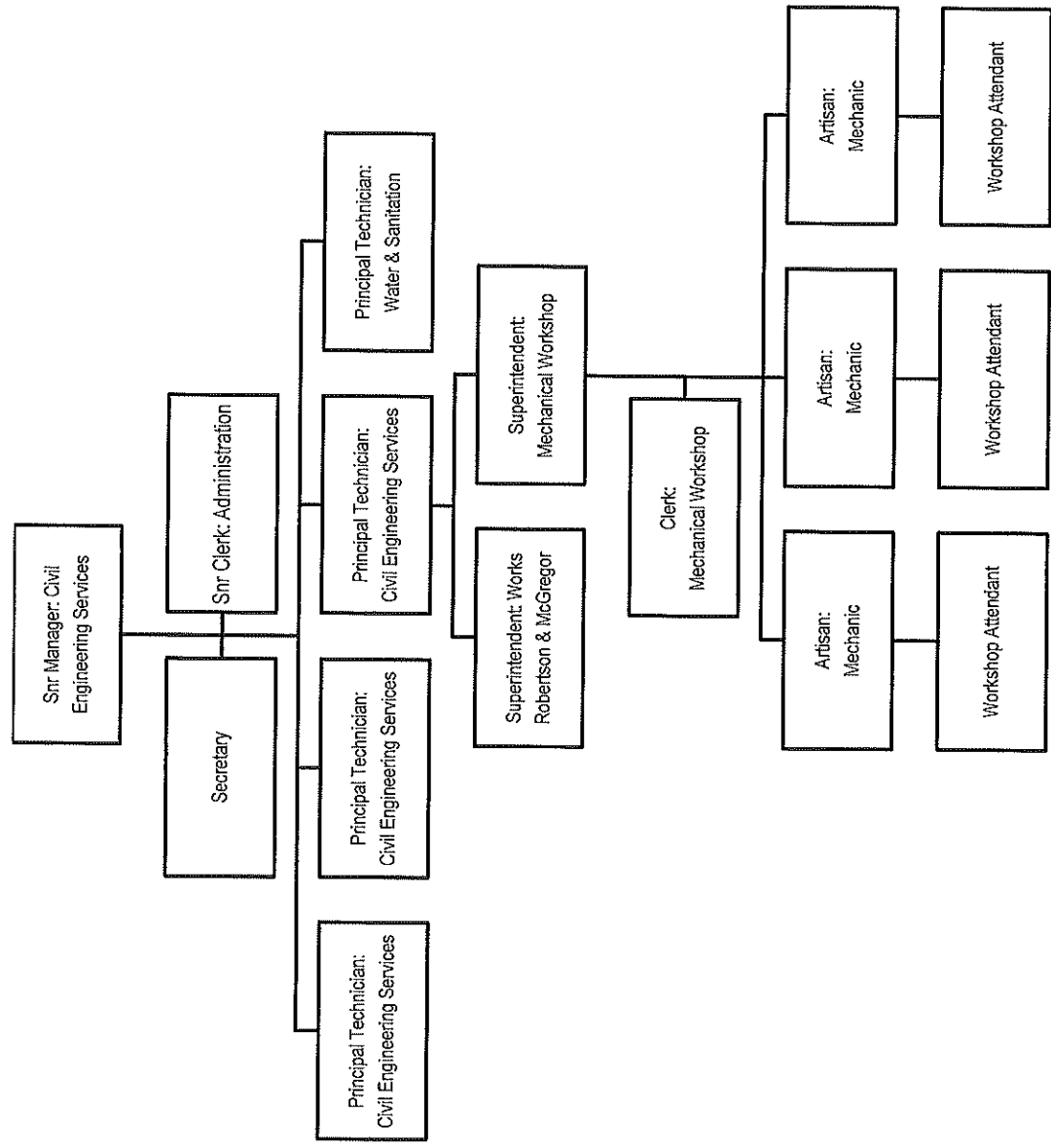

ORGANISATION STRUCTURE: CIVIL ENGINEERING SERVICES – ROBERTSON & MCGREGOR

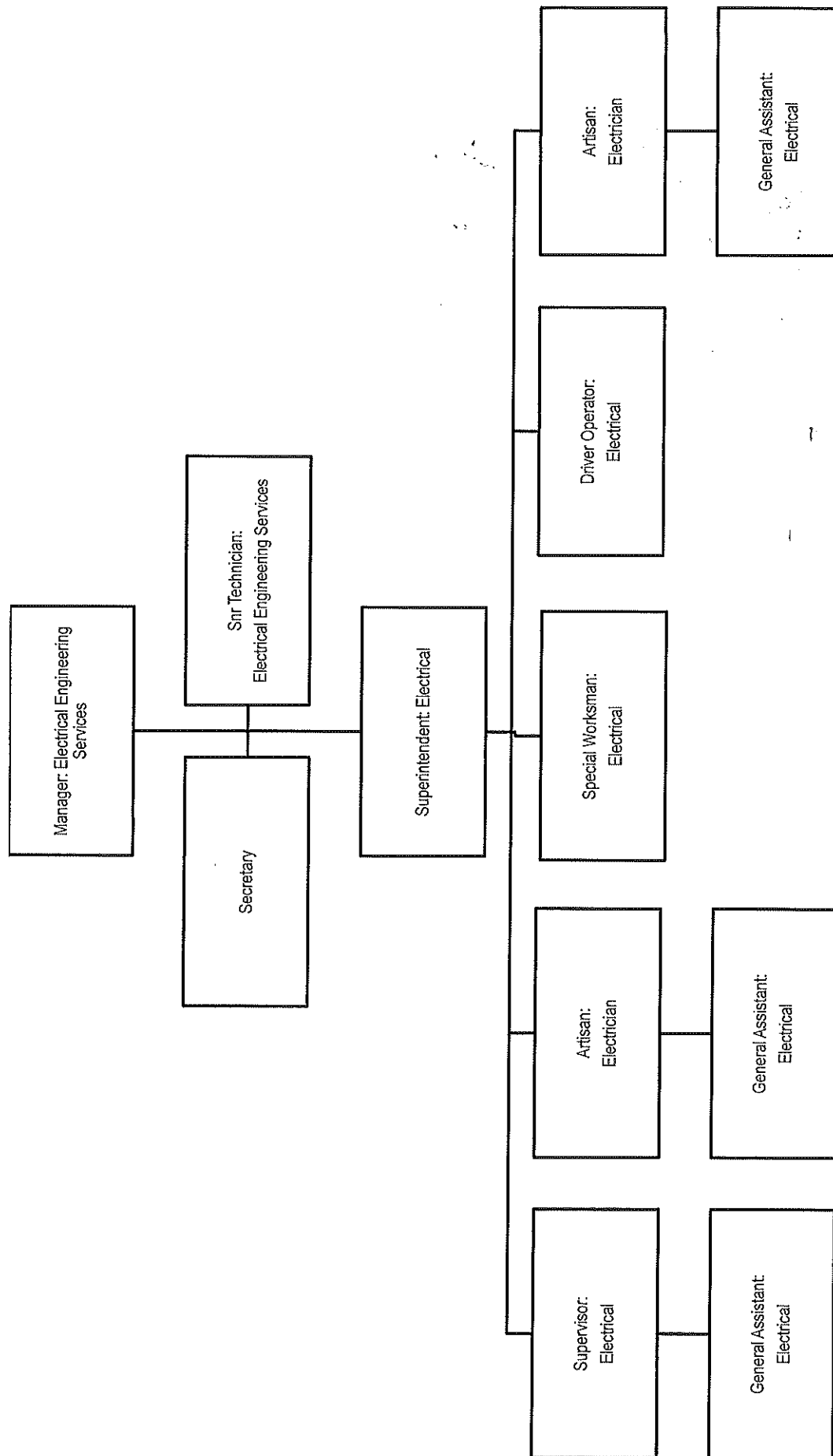
