Notice is hereby given that the Integrated Development Plan is open for perusal at all Municipal Offices and Libraries in Langeberg area from 1 April 2015 to 30 April 2015. The draft of the Integrated Development Plan and Budget 2015/2016 was tabled at Council on 25 March 2015.

Chapter 4 of the Municipal Systems Act 32 of 2000 states that all municipalities must develop a culture of municipal governance that compliments formal representative government with a system of participatory governance, and must for this purpose encourage and create conditions for the local community to participate in municipal affairs, including the preparation, implementation and review of its integrated development plan in terms of chapter 5 of the Act.
