1. Introduction

Afrimat in conjunction with DMR and Langeberg Municipality, calls for expression of interest from prospective bidders within the Langeberg area with the capacity to facilitate and manage the Learners and Drivers

License Programme over a year period commencing in February 2016.

A key priority of Afrimat is the enhancement of economic opportunities and employability options, particularly in marg inalized communities. In recognition of the need to assist community members to obtain driver's licenses, which augm ent employability, Langeberg Municipality will assist the selected candidates to obtain their Learners Licence, and Afri mat will administer the **Driver's License Programme**. Under the programme, 18 community members will benefit from

Afrimat funded training in Code 14 learners license concepts, and or practical driving lessons which will be facilitated by the appointed service provider. The broad objectives of the programme are twofold:

- i) To provide Code 14 (Learner's License) training to the selected beneficiaries, and facilitate the process of obtaining their learner's licenses
- ii) To provide Code 14 practical driving training to selected community members, and facilitate the process of obtaining their driver's licenses

2. Specifications

2.1 Drivers License Programme

Selection of Beneficiaries

The selection of beneficiaries will be the responsibility of the Langeberg Municipality.

Afrimat will reserve the right to appoint the service provider in the area based on the vendor's capacity and resources

Expected Deliverables

Service providers of the Driver's License Programme will be expected to provide practical training that will equip learner

drivers to be able to operate a vehicle, and pass the Code 14 Driving Test, and obtain a drivers' license. The following ser vices will be required: **to train 18 candidates**

- i) Facilitation of test bookings for participating beneficiaries at the Traffic Department. This will include collecting photographs and ID copies from the trainees, and upfront payment of required booking fees
- ii) Conducting the required number of driving lessons with the learner driver. Each driving lesson must be a minimum of 1 hour, and learner driver will be expected to sign the trainer's time log sheet
- iii) Facilitation of the testing process, including providing a vehicle for the learner driver on the day of the test.
- iv) Service providers to include at least one more lesson and testing at no charge to Afrimat if candidates fail either learners or drivers testing
- v) Service providers to ensure that a minimum pass rate of 80 % is achieved

Appointed service provider will be expected to sign a Service Level Agreement prior to commencement of service.

Training Times

Each driving lesson shall be a minimum of 1 hour, and a maximum of two lessons may be conducted on one day. Service providers will be expected to be on time. Trainers will be expected to maintain a time log sheet, recording the starting an d ending times per lesson, which must be signed by the respective learner driver. The instructors of appointed service providers must have proof of an Instructors Certificate.

Condition of Vehicles

The appointed service provider will be expected to provide registered vehicles with comprehensive insurance and certified as roadworthy.
