# RECOGNITION OF CUSTOMARY MARRIAGES AMENDMENT BILL [B 12–2019]

The Western Cape Provincial Parliament's Standing Committee on Community Safety, Cultural Affairs and Sport invites stakeholders and interested parties to attend a public hearing on the Recognition of Customary Marriages Amendment Bill [B 12–2019] being organised as part of the Standing Committee's constitutional responsibility.

The purpose of the Amendment Bill is to regulate further the proprietary consequences of customary marriages entered into before the commencement of the Recognition of Customary Marriages Act, 1998 (Act 120 of 1998). This is in order to bring the provisions of the Act in line with the judgments of the Constitutional Court as the Court found certain provisions to be constitutionally invalid because these provisions discriminate unfairly against certain women in customary marriages. The effect of this amendment is that the proprietary consequences of a polygamous customary marriage will no longer be governed by customary law.

# WYSIGINGSWETSONTWERP OP ERKENNING VAN GEBRUIKLIKE HUWELIKE (“RECOGNITION OF CUSTOMARY MARRIAGES AMENDMENT BILL”) [W 12– 2019]

Die Wes-Kaapse Proviniale Parlement se Staande Komitee oor Gemeenskapsveiligheid, Kultuursake en Sport nooi belanghebbendes en belangstellende partye uit om 'n openbare verhoor oor die Wysigingswetsontwerp op Erkenning van Gebruiklike Huwelike (“Recognition of Customary Marriages Amendment Bill”) [W 12–2019] by te woon wat as deel van die Staande Komitee se grondwetlike verantwoordelikheid gereël word.

Die doel van die Wysigingswetsontwerp is om die vermoënsregtelike gevolge van gebruiklike huwelike wat voor die inwerkingtreding van die Wet op Erkenning van Gebruiklike Huwelike, 1998 (Wet 120 van 1998), aangegaan is, verder te reguleer. Dit is ten einde die bepalings van die Wet in ooreenstemming te bring met die uitsprake van die Konstitusionele Hof aangesien die Hof bevind het dat sekere bepalings grondwetlik ongeldig is omdat hierdie bepalings onbillik teenoor sekere vroue in gebruiklike huwelike diskrimineer. Die gevolg van hierdie wysiging is dat die vermoënsregtelike gevolge van poligame gebruiklike huwelike nie langer aan die gewoontereg onderhewig is nie.
